It is in the form of a globe, and holds two gallons. Surmounting the globe, which is of highly-polished silver, is a frosted silver figure of Cupid in a reclining posture, with his left hand on a laurel branch, which is kept ever green and fresh from a watering cup held in the right hand. Tho construction of the legs supporting the globe, the ob-long base for the cup to rest upon, and in fact the whole design and construction of the urn are both novel and beautiful. The whole rests upon an oval-shaped plateau two feet or more in diameter, with an elegantly-chased rim. In the centre of the plateau and also on the front surface of the globe, are tho unitals C.
