THIS IS UNEVALUATED INFORMATION. SOURCE GRADINGS ARE DEFINITIVE. APPRAISAL OF CONTENT IS TENTATIVE.

SOURCE A MEMBER OF A GROUP OF CUBAN EMIGRES TRAINED IN THE TECHNIQUES OF INFORMATION COLLECTION. THE GROUP HAS PROVIDED USEFUL REPORTS FOR OVER TWO YEARS. THIS INFORMATION WAS OBTAINED FROM FRANCISCO (DOMINGUEZ) MAIDAGAN, A MEMBER OF THE SEGUNDO FRENTE NACIONAL DEL ESCAMBRAY.

1. ACCORDING TO STATEMENTS WHICH HAVE BEEN MADE BY AURELIO (NAZARIO) SARGENT IN THE OFFICES OF THE SEGUNDO FRENTE NACIONAL DEL ESCAMBRAY (SFNE, SECOND NATIONAL FRONT OF THE ESCAMBRAY) - ALPHA 66 - MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (MRP, PEOPLES REVOLUTIONARY MOVEMENT) COMBINE, PLAN "OMEGA" WILL BE ACTIVATED SOMETIME BEFORE 30 NOVEMBER 1963, WITH DEPARTURES SCHEDULED FROM BASES IN THE YUCATAN PENINSULA, SANTO DOMINGO AND PANAMA.
2. ELOY (GUTIERREZ) MENOYO IS THE MILITARY CHIEF OF THE PLAN OMEGA WHICH INVOLVES LANDINGS AND INFILTRATIONS AT THREE POINTS IN LAS VILLAS, AND ENGAGING IN GUERILLA ACTIVITY AND SABOTAGE IN CUBA.

GUTIERREZ INTENDS TO BE A MEMBER OF THE INFILTRATING TEAMS, HOWEVER AT PRESENT THE PLAN IS TO LIE LOW FOR ABOUT ONE MONTH AFTER INFILTRATION, TO PERMIT FOR CONSOLIDATION OF ASSETS.

3. ASSISTING GUTIERREZ IN THE MILITARY ASPECT OF PLAN OMEGA ARE OCIEL GONZALEZ, FORMER CHIEF OF THE HABANA FIRE DEPARTMENT, AND AMAURY (FRAGINALS) ALONSO, LEADER OF THE HABANA ELECTRIC SECTOR WORKERS. RENE (CRUZ) PEREZ, A MEMBER OF SFNE, IS ALSO ASSISTING IN THE MILITARY ASPECT OF PLAN OMEGA.

4. NAZARIO IS SAID TO BE IN CHARGE OF SUPPLIES FOR PLAN OMEGA. IN ADDITION THE SFNE-ALPHA-66 - MRP COMBINE HAS BEEN TALKING TO CARLOS (PRIO) SOCARRAS RELATIVE TO THE FINANCIAL ASPECTS OF PLAN OMEGA. AN INDIVIDUAL IDENTIFIED AS RICARDO (BIANCHI) ARGUELLES, A PERSONAL FRIEND AND IN THE COMPLETE CONFIDENCE OF PRIO, HAS BEEN A FREQUENT VISITOR TO THE OFFICES OF THE SFNE-ALPHA 66-MRP COMBINE TO DISCUSS VARIOUS ASPECTS OF PLAN OMEGA.
