DEFENDANTS' MOTION FOR AN ORDER DIRECTING THAT THEY BE TRANSFERRED TO WASHINGTON, D.C.

Defendants Guillermo Novo Sampol and Alvin Ross Diaz hereby move this Court for an order directing that they be transferred to Washington, D.C. Preliminarily, such a transfer is necessary so that the defendants may be present at the proceedings on the bail applications which have been submitted in their behalf herewith.

In the event that the defendants are unable to post the bail set by the Court, counsel will then request an order directing that they be transferred from Washington, D.C. to the Metropolitan Correctional Center in New York, where their attorneys' offices are located and where these defendants were housed prior to their first trial. Such a transfer is necessary in order to enable these defendants and their attorneys to prepare for the retrial which had been ordered by the Circuit Court. As this Court is aware, the first trial lasted for approximately six weeks, and presented a large number of complex factual and legal issues. Moreover, substantial new information has come to light since that trial. Consequently, preparation for retrial will require extensive praparation, including frequent consultation between the defendants and their lawyers.

It is well established that pretrial incarceration handicaps a defendant in preparing his defense and therefore increases his chances of being convicted. If the defendants are unable to post bail, then it is imperative that they at least be transferred to New York so that they may be accessable to their attorneys. As was demonstrated at the first trial, these defendants are not wealthy and cannot afford to pay to have their attorneys visit them at their present places of incarceration for such consultations. Moreover, it is important to the defense of this case that such consultations be conducted with both defendants together.

WHEREFORE, it is respectfully prayed that this Court enter an order directing that these defendants be transferred to Washington, D.C.
