On 5 April 1978 this writer observed subject ROSS arrive at 5605 N. W. 7 Street, the Toledo Plaza Apts. The subject arrived at approximately 8:30 p.m. and proceeded to unload suitcases from the trunk of his car, a 1978 Lincoln Continental with a grey Landau roof and a sun roof, bearing a temporary New Jersey tag with no number.

The subject was observed by this writer speaking to a subject who was helping him with the luggage. The subject is an unknown W/M approximately 40 years, 5'8", 165 lbs., dark skin, black hair. This writer overheard ROSS telling the subject it had taken him fourteen hours of driving. This writer could not hear the location he came from.

Subject ROSS is staying in the apartment where the second subject resides; the apartment is on the second floor of the building, and the second subject is possibly MIGUEL MEDINA, a relative of ROSS.

The New Jersey temporary tag has information on it indicating the following:

> ALVIN ROSS 9390 S. W. 38 Street Miami, Florida

There is also a stamp on the tag indicating "non-resident."

An inspection sticker (N.J.) on the vehicle indicates the number 187556.

A check with FBI S/A O. Cervantes indicates that MIGUEL A. MEDINA of 9390 S. W. 38 Street is ALVIN ROSS's stepfather.

On 13 April 1978 at 10:30 a.m. this writer observed ROSS along with possible subject MEDINA, and a third unknown W/M, depart the apartment complex. The third subject is a W/M, dark skinned, black hair thinning at the top, 5'10"-5'11", 180 lbs., 45 years.

This writer overheard the three subjects talking about an address, however all this writer could make out was southwest. Subject ROSS then entered his vehicle and followed the other two subjects who were in a vehicle being driven by possible subject MEDINA.

The second vehicle is a 1977 4 dr. Chevrolet Nova, brown in color bearing a Florida tag #1E-77774. A check of the tag revealed it is leased from Anthony Abraham Leasing. A check with Abraham Leasing revealed this vehicle is rented to REINALDO MENENDEZ of 25 W. 50 Street, Hialeah.

FBI S/A Cervantes has been apprised of the above information.

11:25 p.m. Subjects are observed driving east on Coral Way. Surveillance dropped.

11:45 p.m. FBI agents advised they observed subjects in the ar of 36 Avenue and N. W. 7 Street making a series of

Suspect Sought In Bomb Death

FBI and local police agencies are seeking a third anti-Castroite for questioning in the investigation of the 1976 bombing death of former Chilean ambassador Orlando Leteli-

William Birtwistle, a spokesman for the FBI in Newark, N.J., said agents want Virgilio Paz Romero 26, believed to be a close associate of Guillermo Novo and Alvin Ross Diaz, who were arrested here this month.

Paz, a used car salesman, is be-lieved to be "armed and danger-ous," according to Birtwistle. Fingerprints belonging to Paz were found on chemical bottles (of

a variety capable of producing a bomb) in a room in Newark used by the three men.

Novo, held without bond, was arrested here on charges of failing to appear for a probation revocation hearing in New Jersey. The charge was placed after he allegedly traveled to South America without permission of his parole officer.

Ross was arrested on charges stemming from the January bombing of a Newark store.

FBI's hunting for Novo pal and Ross Diaz

A federal warrant charges Virgilio Paz Romero with bomb-making. His fingerprints were found in Ross Diaz Union City, N.J., office where explosive components were seized, according to an FBI affidavit filed in U.S.

District Cou t in Newark, N.J. An FBI s ookesman in Newark said an all-points alert is under way for Paz, believed to be "armed and dan-The spokesman said the search is concentrating along the eastern seat pard, particularly in Miami."

The affidavit says two of Paz' prints were found on a bottle partly filled with an incendiary-type chemical substance. Faz was decribed as a Union City car salesman, who, like the two other men, is a member of the Cuban Nationalist Movement a militant anti-Castro or-

The aff davit states Novo's thumbprint was found on one of hree letters typed over his name and also found in Ross Diaz' office.

The information in the affidavit places all three in the room where the explosive components and a weap-

ons ledger were found.

The affidavit does not reveal the contents of the Novo letters, dated July 5, 1976. But it states that explosive components were in Ross Diaz' possession "at least as early as July 6, 1976, to at least as late as November 1, 1977." On that date Ross Diaz was evicted from his office for not paying rent, the affidavit says.

That time span places the explosive components in Ross Diaz' possession more than two months before the Letelier bimbing in Washington, D.C., on Sept. 21,

The affidavit says that a 16-ounce bottle found in the office was half-filled with potassium permanganate (a heat intensifier used in incendiary devices), and none of the eight ounces missing from the bottle were found in said room." The affidavit says a substantial. amount of gun powder removed from shotgun shells also was missing from the office when the FBI searched it last month.

"Persons having access to said room have probably made a destructive device," concludes the affidavit,

which was signed by FBI bomb expert William Gilman. Gilman and the FBI spokesman in Newark would not comment whether the bomb used to kill Letelier was made of materials said to be missing from the of-

The affidavit for the first time links the two organizations, CNM and Omega 7. The CNM has been involved in terrorist activities in the past, both inside and outside the U.S.," the affidavit says. "Under the aegis of Omega 7, it has claimed credit for at least three bombings in New Jersey since September 1976.'

Novo, a fugitive for the last 10 months, was arrested here April 14 with Ross Diaz. Novo was charged with falling to show up at a probation revocation hear-

ing June 6.

A probation revocation motion filed in the U.S. court in Newark says Novo violated probation by traveling to Venezuela and Chile after his 1974 sentence for conspiring to destroy the Cuban consulate and trade mission in Montreal.

Novo took action to conceal his travel and its purpose from the lawful authorities . . . In addition, the evidence will show Novo was traveling with Orlando Bosch, said the motion, signed by Assistant U.S. At-torney Eugene Propper. Propper heads the Letelier murder investigation.

The Letelier bombing was "the background leading to the motion for revocation of probation," the motion says. "As a result of investigation into the murders by

the FBI, Novo's foreign travel came to light.

The trips to Venezuela and Chile are very important to the grand jury's investigation of the (Letelier) murder and Novo was questioned about them in two appearances before the grand jury," the motion states.
While investigating the CNM "as it relates to possi-

ble violations of the Neutrality Law Act," FBI agents

went to a "commercial-residential building" at 4523 Bergenline Ave., Union City, on Feb. 28, the affidavit

The superintendent of the building identified pictures of Ross Diaz as having rented an office for the C & P Novelty Co. under the name of Carlos Garcia, according to the affidavit.

On March 8, the affidavit says, the superintendent called the FBI and said that while cleaning the office left vacant since Ross Diaz was evicted, he had found

items that might be of interest to the agency.

The affidavit says agents found more than eight feet of detonating cord, 18 12-gauge shotgun shells with all the gunpowder removed, the half-empty bottle of potassium permanganate, eight electric matches (a device that can be used to ignite low explosives), about nine primer caps, the weapons ledger and the Novo let-

All the items except for the shotgun shells, the Novo letters, and the weapons ledger were found in a

The ledger gave detailed descriptions of 27 weapons, among them a two-barreled nickel-plated shotgun, sawed-off 12 gauge shotgun, M-1 rifle and 11 handguns.

The ledger cataloged the weapons as being in two locations, identified only as "#1" or "#2" and "in charge of", or "in possession" of persons identified by initials.

It also listed a wide variety of grenades, detonator cords, fuse igniters, mercury contact capsules, unre-paired watches, a quantity of "soaps and detergents" and music equipment.

The FBI refused to say whether any of the weapons described in the ledger had been found or traced to ter-

rorist acts.

FBI Uncovers Records Showing Townley Contacted Cuban Exiles

WASHINGTON — (AP) — An merican being held as a material vitness in the 1976 bombing assassnation of Orlando Leteller contacted Cuban exiles at least twice I rior to the killing, a Justice Department source says.

The source, who asked not to be identified, said Wednesday night that the FBI has uncovered telephone records showing that Michael V. Townley, the American, made two calls to Cuban exiles in New Jersey.

Federal investigators are reportd to believe the assassination in Washington of Letelier, a former eft-wing Chilean official, was caried out by Cuban exiles under orlers from Chile's secret police.

THE INVESTIGATORS suspect hat Townley was a go-between with a group of Cuban exiles who allegedly placed the bomb,

Investigators think that Townley was working for DINA, a now-disbanded unit of Chile's secret police, when he traveled to the United States on a Chilean passport in August 1976

The source said Townley placed one call to a bar in Union City, N.J., frequented by Cuban exiles and another to the home in Cliffside Park, N.J., of a suspect in the assassination. The source did not identify the

Townley, 35, has lived in Chile most of his life. He was deported from Chile to the United States earlier this month as a result of heavy pressure from the U.S. government. After his arrival, Townley was ordered held without bond as a material witness:

Letelier, a cabinet minister in the

government of the late Marxist President Salvador Allende, was jailed for a year after the military coup in 1973.

After his release, while in exile in Washington, Leteller was killed when a bomb exploded under his car on Sept. 26, 1976.

LAST WEEK, two Cuban exiles from New Jersey were arrested in Miami on charges unrelated to the assassination. However, a source in Washington said the two are linked to the Letelier investigation.

Guillermo Novo Sampol/38, who filed authorities in New Jersey after his conviction in connection with a

1974 plot to destroy the Cuban consulate in Montreal, was arrested as a probation violator.

The other man, Alvin Ross Diaz. 45, was charged with conspiracy to make explosives and incendiary devices.

The source said the FBI discovered that Guillermo Novo traveled to Chile shortly before Letelier's killing.

The source added that Diaz was subpensed last spring and granted immunity from prosecution to testify before a grand jury. Diaz refused to testify and was not called before the grand jury.

Home Held Bomb Gear, FBI Says

Electronic gear like that used to make sophisticated bombs was found in the home of one of two anti-Castro militants now under arrest, an FBI agent testified Thursday in Miami federal court.

FBI Agent Ovidio Cervantes testified that electronic circuit boards were found in the Union City, N.J., home of Alvin Ross

Ross and Guillermo Novo
Sampol, 38, are subjects in the
current investigation of the 1976
murder of former Chilean ambassador Orlando Leteller in
Washington, D.C., Cervantes testified.

They were arrested last Friday in Miami with <u>Manuel Menen-</u> dez, a suspected drug dealer.


"ROSS WAS associated with Menendez, who is involved in a conspiracy to distribute more than 41 pounds of heroin valued at more than \$10 million in Las Vegas, New York and Miami," Cervantes swore.

Ross had a pound of cocaine, wrapped in metal foil and plastic wrap in the trunk of the 1977 Lincoln Continental he was driving when he was arrested, Cervantes said.

Four pistols also were found, two of which belonged to Menendez, Cervantes told U.S. Magistrate Herbert Shapiro.

The testimony came during a bond hearing for Novo and Ross. Novo is wanted for parole violation by New Jersey authorities. Ross faces federal charges in a bombing last December in New Jersey.

Judge Shapiro set a \$200,000 bond for Ross and told Novo that he would not be allowed to post bond because Novo had failed to keep federal court appearances in New Jersey.

BOTH MEN will go to New Jersey to face charges.

Ross told the court that he runs a promotion company which helps other firms sell things, and also sells used cars.

Born in Cuba, Ross said he is a permanent resident alien in the United States and has been arrested only once before on charges of interstate transportation of a stolen pistol from Miami to Union City.

The charges for the transportation of the stolen pistol still are pending, and Cervantes said Ross is wanted for falling to appear in court on those charges.

Cervantes also said that he could produce witnesses from the Dade County Jail, where Ross and Novo have been held since their arrest, who would

testify that the two men have made threats against the FBI, court and jail personnel.

"In essence," Cervantes said,
"they said everything will be
blown away because of the way
they have been handled."

Defense attorney Stuart Wilson argued that the charges against his clients, including the alleged threats, were insubstantial and that both men should be released on bond.

"There is nothing concrete against these men," Wilson argued.

Novo did not testify and no evidence was presented against him in court because of the fact that he was ineligible for bond and must be returned to New Jersey to stand trial.

Beeper in Cuban Militant's Car Is Probed in Letelier Bombing

The FBI is trying to determine whether an electronic beeper found in a car driven by an anti-Castro militant was used to detonate the bomb that killed former Chilean foreign minister Orlando Letelles in Washington, D.C., in 1976.

In a sworn statement filed in federal court Wednesday, Miami FBI. Agent George F. Cannon, Jr. said the beeper, found in the glove compartment of a gray 1977 Lincoln Continental driven by Alvin Ross Diáz, may be linked to the Letelier assassination.

"It is my belief that the electronic pager or beeper with in the glove-box of the ... Lincoln Continental may have been used as the device which caused the explosion of Leteler's car on September 21, 1976,"

Cannon said in the affidavit, written to support a search warrant for the car.

"It is believed by members of (an) FBI Laboratory team that an electronic pager or beeper may have been used to detonate the explosive destructive device in Letelier's car," Cannon said.

The statement tends to confirm speculation that the bomb that killed Letelier in his car was detonated by remote radio control. The beeper has been sent to an FBI laboratory for study, a source close to the investigation said.

Federal investigators are known to believe that Letelier, once an official in Chilean President Salvador Allende's Marxist government, was murdered by Cuban militants acting under the direction of Chilean secret police agents. Diaz and an a fel-

low militant Guillermo Novo, investigators have said, are central figures in the case.

Diaz and Novo were arrested April 14 in Dade County and were transferred to New Jersey to face federal charges unrelated to the Letelier bombing. Both men are members of the Cuban Nationalist Movement (CNM), "also known to the FBI as Omega 7..... The Letelier investigation has focused on these organizations," the affidavit added.

"I would think they would have an idea as to the nature or the type (of beeper). I don't know what would lead them to believe that the pager was the one he (Diaz) had in his car," said Diaz' attorney, Donald Spain, "It sounds to me that they're really groping. I just think the government is frustrated."

Charged in Letelier Case

TRENTON, N.J. — The Justice Department Thursday charged Guillermo Novo, an anti-Castro Cubar-American, with conspiracy in the 1976 car-bomb assassination of former Chilean diplomat Orlando etelier.

No o, 38, is the fifth member of the Miami-based Cuban Nationalist Movement of be charged with con-spiracy in Letelier's death in Washingto. A sixth man, American expatriate Michael Townley also has been charged with conspiracy and reportedly is cooperating with federal investigators.

In another significant development in the Letelier case Thursday. sources in Washington said U.S. officials are arranging to bring the former head of Chile's secret police

to the United States.

Travel plans for Manuel Contreras are indefinite, the sources said. Contreras headed the feared Directorate of National Intelligence (DINA) at the time of Letelier's death and was a vocal critic of Letelier

LETELIER WAS a member of the government of Marxist Chilean President Salvador Allende, overthrown in September 1973. Allende died during the ouster; Letelier came to the United eventually.

States in exile after Chile was taken over by a military junta led by Gen.

Augusto Pinochet,

U.S. investigators say they believe that Guillermo Novo and the other members of the Cuban Nationalist Movement were hired to assassinate Leteller. However, the movement maintains the six suspects are being framed in an attempt by the United States to improve relations with Fidel Castro's

Communist government in Cuba. Eugene M. Propper, assistant U.S. attorney who heads the Letelier investigation, announced the conspiracy charge against Novo during a parole violation and revocation hearing before U.S. District Judge George H. Barlow.

Barlow found Novo guilty of four parole violations - one of them being a trip to Chile and Venezuela in late 1974 without the knowledge of Novo's parole officer - and sentenced him to 21/2 years in prison.

NOVO'S PROBATIONARY status stemmed from a conviction for plotting in 1969 to blow up the Cuban Embassy in Montreal and Russian ships in Canada. After Barlow sentenced him Thursday, Novo was returned to the federal Metropolitan Corrections Center in New ork City.

Propper said he expects a grand jury investigating the Letelier case to return indictments soon. He indicated that more charges - possibly for murder - will be leveled against some or all of the six men who have been charged with conspiracy.

The most damaging evidence at Novo's parole-violation hearing came from Ernest L. Barcella Jr., an assistant U.S. attorney who testified that a high-ranking official in the Venezuelan secret police told him that Novo was in Venezuela in late 1974.

Barcella said that Rafael Rivas the Venezuelan secret police, told him he had spoken to Novo while Novo was in his country.

"VASQUEZ SAID he told Novo that his passport would reflect that he went out of the country," Barcella testified.

"Vasquez told me that Novo replied he would toss his passport in the river." Other testimony showed the passport never was found.

Novo's lawyer, Paul Goldberger, argued that the only reason Propper brought the parole-violation charge against Novo was to find some way to hold him until Propper could charge Novo in the Letelier case.

Besides Novo and Townley, others charged in the Letelier case are Ignacio Novo, Guillermo's 30/year-old brother, Dionisio Suarez, Virgilio Paz, and Alvin Ross Diaz, who was charged on Wednesday.

Suarez and Paz are being sought by the FBI. The others are in custo-

Cervantes stated that RAUL JESUS GONZALEZ, a member of the MNC (MOVIMIENTO NACIONALISTA CUBANO) had aided PAZ as of 10 May 1978. Upon interviewing GONZALEZ, he admitted to having helped PAZ, stated he would continue to do so, and would not hesitate to do it again if necessary.

Cervantes advised this writer he is presently pursuing attempts to obtain warrants for the arrest of GONZALEZ on charges of harboring a fugitive.

The FBI is continuing attempts to locate PAZ and SUAREZ.

SYNOPSIS:

Information received in reference to <u>CUBAN DOCTORS ASSOCIATION</u> meeting and information reference possible location of VIRGILIO PAZ ROMERO and DIONISIO SUAREZ ESOUIVEL.

DETAILS:

This detective received unverified information about the CUBAN DOCTORS ASSOCIATION in the U.S., that they were going to have a convention in Miami on 28 June 1978 through 4 July 1978. The convention was to be held at the 4 Ambassadors Hotel. The information further stated that JUAN B. PULIDO would be attending the convention. JUAN B. PULIDO has been named previously by the FBI as an associate of MANOLO REBOSOLIN Miami and a member of the MNC (CUBAN NATIONALIST MOVEMENT) in New Jersey, and a close associate of GUILLERMO NOVO-SAMPOL and ALVIN ROSS DIAZ. PULIDO has also been named as being a fund raiser for ORLANDO BOSCH AVILA. This information was made available to the FBI.

On Monday, 3 July 1978, this detective advised FBI Agent Cervantes that their convention was in progress and that PULIDO might attend, in case they had an interest. Cervantes requested that verification of PULIDO'S arrival in Miami would be useful to them.

On 5 July 1978 this detective was able to verify PULIDO being in town due to some visual observation being made of him at the convention by a fellow Cuban doctor. This information was relayed to this detective and forwarded to the FBI by this detective.

On 6 July 1978 this detective obtained further information from Det. Rapado as to DR. JUAN B. PULIDO, DR. ROMENECH, and JOSE TENREIRO being in Miami and planning to have some meetings in the Miami area.

On 7 July 1978 this detective received information which was mostly known to this detective. The information alleges that DUNNEY PEREZ ALAMO is a Cuban Castro agent and a front for Cuban cocaine smuggling, and currently working for WFC. It alleges further that DUNNEY had been a captain in the Castro army and that he had been a very close friend and partner of JOSE DIONISIO SUAREZ ESQUIVEL. That DIONISIO was also a Castro agent. That DIONISIO SUAREZ was probably in Miami and that if anyone knew the whereabouts of DIONISIO SUAREZ it would certainly be DUNNEY PEREZ ALAMO.

A routine check was made with New York City P.D. to verify that JUAN B. PULIDO had left their area. During the conversation some

of the prior information was mentioned. New York City stated that some of the information was known to them from FBI sources and it was requested by NYPD to keep the information extremely confidential as the FBI was checking along these lines.

No other information available at this time.

Mrs. DIAZ wanted the release of ROSS DIAZ Lincoln and wanted other miscellaneous ID's, etc. as well as the bond monies. This detective attempted to explain to her that all the property was being held until the prosecutor decided what he would need in his case, and that as soon as this was done all nonevidentiary material would be released by the police. The bond money would have to be up to the judge, as the judge in the case could have estreated the bond. The vehicle was being claimed by two parties, MENENDEZ through Wilson and ROSS through Moore, and that until the dual ownership question would be resolved the department could not really take one man's word over the other's.

On the same date attorney RICHARD MOORE contacted this detective and requested a copy of the title to the car of ALVIN ROSS. This detective explained that he would attempt to obtain a copy from the property room and it would be turned over to him.

The collections were made on July 13. VILLAVERDE had allegedly challenged all the "finks" present to call the FBI and turn him in for being a patriot and helping the NOVOS.

On Monday, 24 July 1978, this detective received information that at 7:00 p.m. at 120 N. W. 27 Avenue, a place called THE CASINO would be hosting a group of persons who would be attempting to raise monies for the payment of legal costs of GUILLERMO NOVO SAMPOL and his brother, IGNACIO, as well as for ALVIN ROSS DIAZ, all of whom have been charged with conspiracy in connection with the fatal bombing of ORLANDO LETELIER and RONI MOFFITT occurring in Washington, D. C. during 1976. An attempt to verify the information did not prove positive.

On the same date a news report on WOBA stated that a fund raising meeting would be held at 152 N. W. 27 Avenue at 7:00 p.m. in benefit of the NOVOS and ROSS DIAZ.
