This is a supplemental response to the Agency's 14 July 1983 letter concerning your 2 June 1982 Freedom of Information Act (FOIA) request made on behalf of your clients J. Gary Shaw and Mark Allen for "all records (including "see references" or cross references) maintained by your agency pertaining to Alpha 66, a Miami-based Cuban exile organization, for the years 1960-1964."


As stated in the 14 July 1983 response, Document F82-0430/141 was sent to another United States Government agency for coordination. The Central Intelligence Agency has received the reply from that agency and Mr. Louis J. Dube, the Information Review Officer for the Directorate of Operations, has made the final determination concerning this document. Mr. Dube has determined that the document may be released in part to your clients. The portions deleted are being withheld to protect information properly falling within the scope of exemptions (b)(1) and (b)(3) of the FOIA.

As you know, exemption (b)(1) of the FOIA encompasses matters which are specifically authorized under criteria established by the appropriate Executive order to be kept secret in the interest of national defense or foreign policy and which are, in fact, currently and properly classified.

Exemption (b)(3) of the FOIA encompasses matters which are specifically exempt from disclosure by statute. The relevant statutes are section 6 of the Central Intelligence Agency Act of 1949, as amended, 50 U.S.C. §403g, which exempts from the disclosure requirement information pertaining to the organization, functions, names, official titles, salaries or numbers of personnel employed by the Agency, and subsection 102(d)(3) of the National Security Act of 1947, as amended, 50 U.S.C. §403(d)(3), which makes the Director of Central Intelligence responsible for protecting intelligence sources and methods from unauthorized disclosure.

A releasable copy of Document F82-0430/141 and a copy of the Deletion Category List are enclosed.

This is in response to your 2 June 1982 Freedom of Information Act (FOIA) request made on behalf of your clients J. Gary Shaw and Mark Allen for "all records (including 'see references' or cross-references) maintained by your Agency pertaining to Alpha 66, a Miami-based Cuban exile organization, for the years 1960-1964."

The Central Intelligence Agency's record review process for this request, listed as F82-0430 (Count 9) under CA82-1603 (prior to consolidation CA82-2388), has been completed. The two hundred fifty Agency-originated documents found during the search of files and the determinations made by Mr. Louis J. Dube, the Information Review Officer for the Directorate of Operations, concerning documents F82-0430/1 through /245; the determinations made by Mr. Thomas B. Cormack, the Information Review Officer for the Office of the Director of Central Intelligence, concerning documents F82-0430/246 and /247; the determinations made by Mr. Paul Marr, the Information Review Officer for the Directorate of Intelligence, concerning document F82-0430/248; and the determinations made by Mr. Karl Muenzenmayer, the Information Review Officer for the Directorate of Science and Technology, concerning documents F82-0430/249 and /250, are identified for you below. As you know, exemption (b)(1) of the FOIA encompasses matters which are specifically authorized under criteria established by the appropriate Executive order to be kept secret in the interest of national defense or foreign policy and which are, in fact, currently and properly classified.

Exemption (b)(3) of the FOIA pertains to information exempt from disclosure by statute. The relevant statutes are subsection 102(d)(3) of the National Security Act of 1947, as amended, 50 U.S.C. §403(d)(3) which makes the Director of Central Intelligence responsible for protecting intelligence sources and methods from unauthorized disclosure, and section 6 of the Central Intelligence Agency Act of 1949, as amended, 50 U.S.C. §403g, which exempts from the disclosure requirement information pertaining to the organization, functions, names, official titles, salaries or numbers of personnel employed by the Agency.

Exemption (b)(6) of the FOIA applies to information the disclosure of which would constitute a clearly unwarranted invasion of the privacy of an individual other than the requester.

Exemption (b)(7)(C) pertains to investigatory records compiled for law enforcement purposes, to the extent that the release of information from such records would constitute an unwarranted invasion of personal privacy. Exemption (b)(7)(C) has been applied only at the request of the Federal Bureau of Investigation.

Exemption (b)(7)(D) of the FOIA applies to information which would disclose the identity of a confidential source, and in the case of a record compiled by an agency conducting a lawful national security intelligence investigation, it applies to confidential information furnished only by the confidential source. Exemption (b)(7)(D) has been applied only at the request of the Federal Bureau of Investigation.

Copies of the documents that have been approved for release and a copy of the deletion category list are enclosed. Please

note that the lettercode "O" has been added to the deletion category list to protect classified information being withheld in Document F82-0430/249 that concerns foreign relations or foreign activities of the United States.

Documents F82-0430/19, /36, /37, /46, and /141 have been sent to other government agencies for coordination. Pending the replies from these agencies, the CIA will make its final determinations concerning these five documents and will advise you of its decisions.

In addition to the records noted above, other United States Government material that may pertain to your clients' request has been found in Agency files. Since this material was originated outside the Central Intelligence Agency, it has been appropriately referred for review and direct response to you.

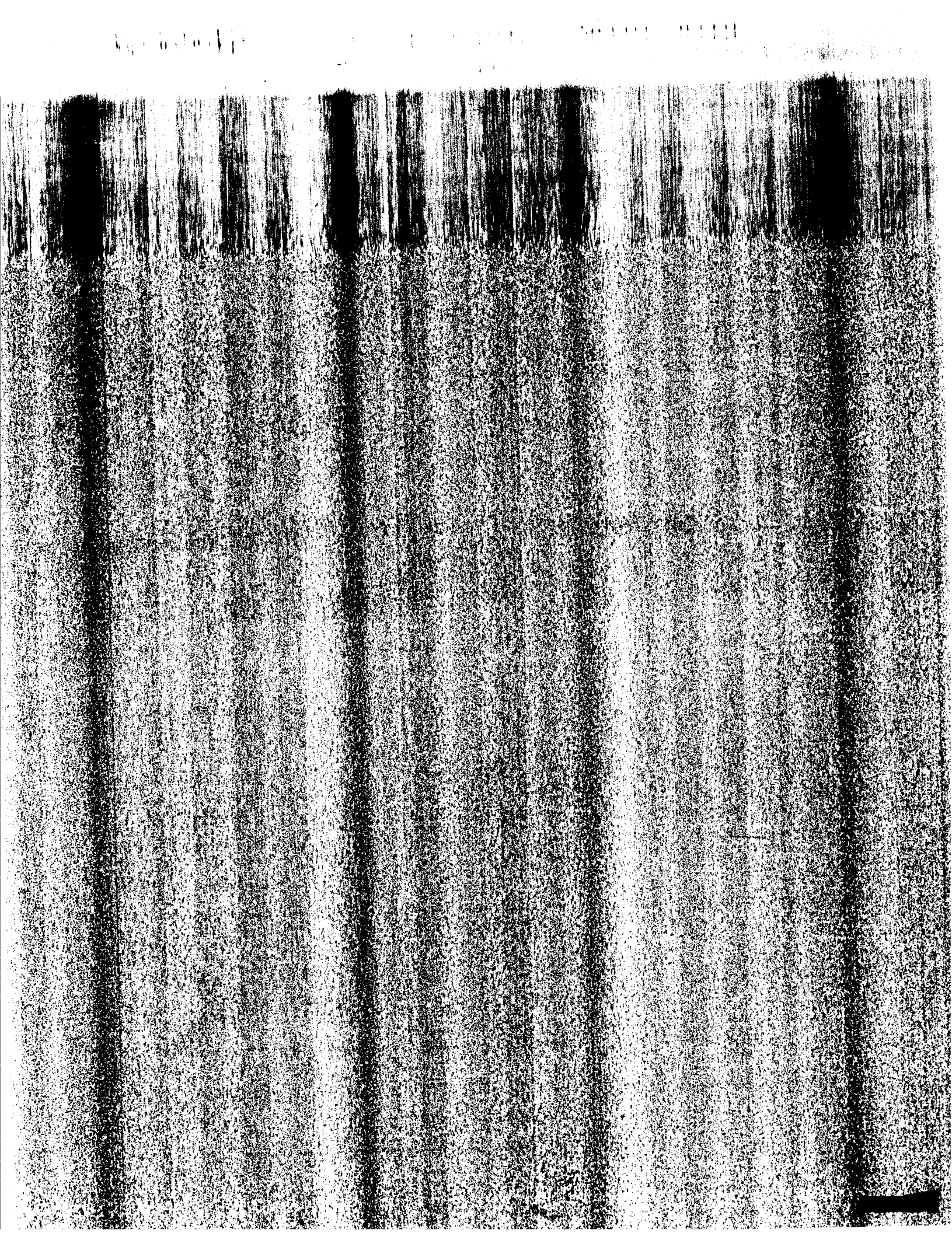

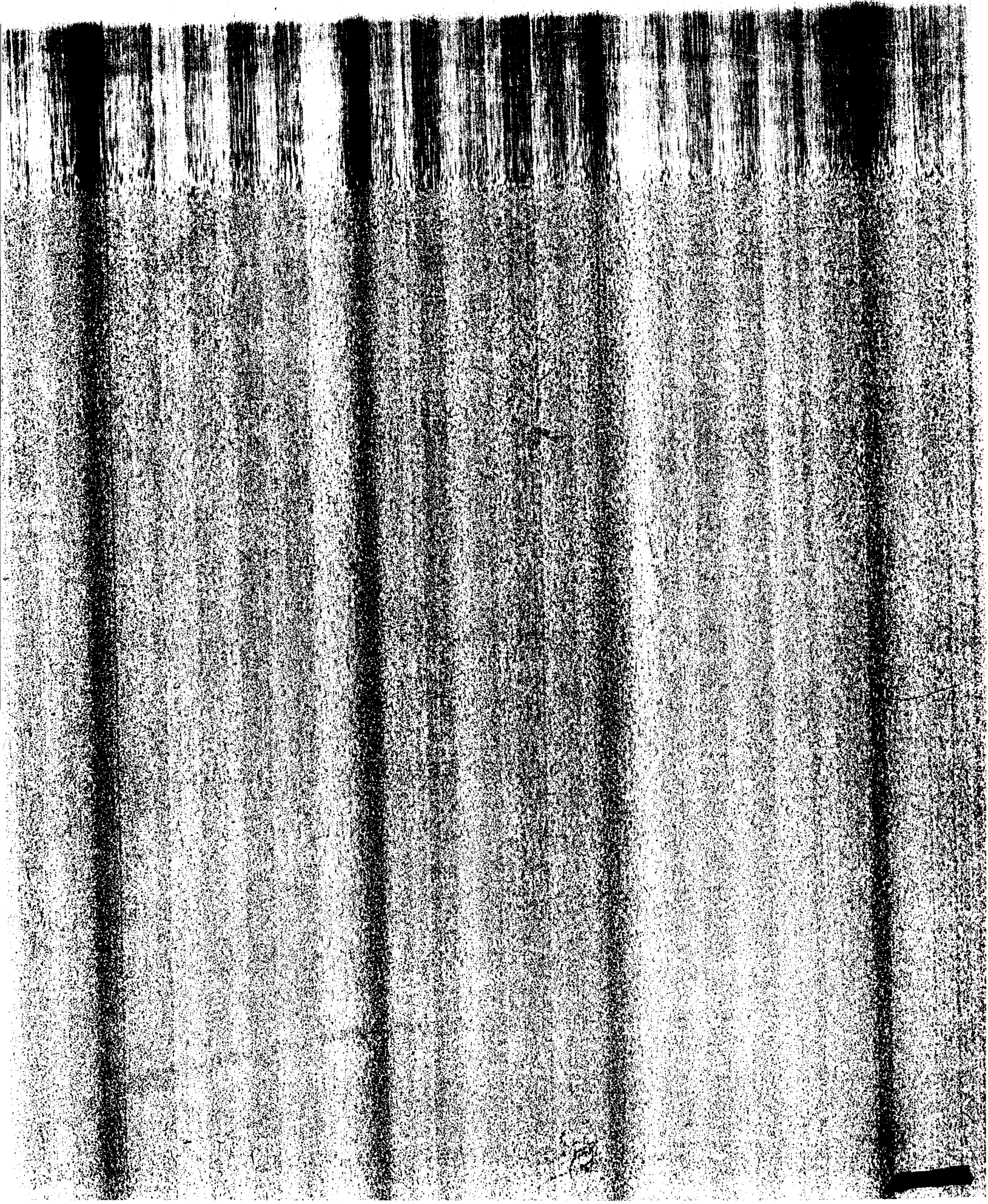

The relevant statutes are subsection 102(d) (3) of the National Security Act of 1947, as amended, 50 U.S.C. §403(d) (3) which makes the Director of Central Intelligence responsible for protecting intelligence sources and methods from unauthorized disclosure, and section 6 of the Central Intelligence Agency Act of 1949, as amended, 50 U.S.C. §403g, which exempts from the disclosure requirement information pertaining to the organization, functions, names, official titles, salaries or numbers of personnel employed by the Agency.

Exemption (b) (6) of the FOIA applies to information the disclosure of which would constitute a clearly unwarranted invasion of the privacy of an individual other than the requester.

Exemption (b) (7) (C) pertains to investigatory records compiled for law enforcement purposes, to the extent that the release of information from such records would constitute an unwarranted invasion of personal privacy. Exemption (b) (7) (C) has been applied only at the request of the Federal Bureau of Investigation.

Exemption (b) (7) (D) of the FOIA applies to information which would disclose the identity of a confidential source, and in the case of a record compiled by an agency conducting a lawful national security intelligence investigation, it applies to confidential information furnished only by the confidential source. Exemption (b) (7) (D) has been applied only at the request of the Federal Bureau of Investigation.

Copies of the documents that have been approved for release and a copy of the deletion category list are enclosed. Please

note that the lettercode "O" has been added to the deletion category list to protect classified information being withheld in Document F82-0430/249 that concerns foreign relations or foreign activities of the United States.

Documents F82-0430/19, /36, /37, /46, and /141 have been sent to other government agencies for coordination. Pending the replies from these agencies, the CIA will make its final determinations concerning these five documents and will advise you of its decisions.

In addition to the records noted above, other United States Government material that may pertain to your clients' request has been found in Agency files. Since this material was originated outside the Central Intelligence Agency, it has been appropriately referred for review and direct response to you.
