Yeah, but in the meantime, what am I, what am I gonna do about these these guys we got now Eddie? What am I gonna do, turn em loose on on on society again and and put em back and let them be everything that you, you want, you know that they are?

We cannot talk by phone so could you make arrangements in order, in order, if you guarantee me, could I, could I talk to you in person and uh, if no we cut it off right here and we don't talk anymore and uh, everybody gotta go, but uh.

What do you wanna do, talk in person?

So, think about it and maybe if I get guarantee I can talk to you without any damage and so we'll meet one more time and let's see what happens, but I have to know, I have to get the guarantee that nothing going to uh, I'll give you time one week or whatever time you need.

Listen. The only thing that you can do to help yourself and to help every, to help this whole thing is come in and g it over with, do what you have to do so you can go back to your people. It's You can't do what you have to do in your position now.

Well ya know if, if you, if you were to come in and talk to us now and help us resolve this thing, the Government attorney and the judges would speak to you about a break. But if, if you're gonna play this way, then they're not gonna talk to you about a break when you get caught some day. Then you're talking about really sacrificing yourself. And all these other guys, Pedro Remon and everybody else is gonna be out there doing what they gotta do and destroying everything that you wanna do.

And I told you already my Supervisor's been transferred. His last day in the office is December 3rd. You know, it's all the soldiers that are getting hurt over this thing. I mean it was, it was, it was nice for you to tell us everything that everybody did in all those past crimes, but we can't prove it.
