CARRERA STATED THAT AS FAR AS HE WAS CONCERNED THIS BOMBING AND THE RESULTING DEATHS, WERE FULLY JUSTIFIED BECAUSE CORU WAS "AT WAR" WITH THE FIDEL CASTRO REGIME. CARRERA CITED THESFACT THAT A WOMAN ABOARD THE CUBAN AIR-LINER WAS A RELATIVE OF ONE OF THE CORU MEMBERS AND THAT THIS WAS REGRETTABLE BUT THAT SUCH PERSONAL TRAGEDIES WERE NOT IN ANY WAY GOING TO STOP CORU FROM CONTINUING ITS ACTIVITIES AGAINST E CUBAN GOVERNMENT. CARRERA INDICATED THAT CORU WAS PLEASED TO SEE THE PUBLICITY GIVEN THE ALLEGATION OF U. S.
