FREDDY LUGO requested through No. 6823, Corporal King, to speak to the Deputy Commissioner of Police, Dennis Ramdwar. Freddy Lugo was reminded that he was still under caution as follows:

"You are not obliged to say anything unless you wish to do so but whatever you say will be taken down in writing and may be given in evidence."

I. FREDDY LUGO, wish to make a further statement. I want someone to write what I say. I have been told that I need not say anything unless I wish to say it and that everything I say may be given in evidence.

I want you, Miss Kelshall, to take down what I want to say.

Since I last spoke to you, Mr. Ramdwar, I remember some other details that are related to this matter.

When we were awaiting the Cubana aeroplane at Piarco in the restaurant I went to the hathroom for about three minutes. When I returned I saw Hernan with his back turned towards my seat. He was playing with something that looked like dough of a whitish or beige colour; he was softening it.

He also had a tube of tooth-paste, Colgate, on the table and it was full as if new. When I approached him and hit him on the back he quickly hid the dough in his pocket and the tooth-paste in his shirt. It seemed to me as if he was trying to flatten the dough so that it could fit in his pocket.

I now remember that when we errived from Caracas and were staying in the Holiday Inn, Hernan asked me to lend him my tooth-brush and tooth-pasts so that he could brush his teeth. I never saw him using the tooth-pasts that he had in Piarco and which he had put in his shirt.

I remember that when by mere in the Cubana seroplane he took the tube of tooth-paste out of his shirt, looked at it and then put it back in his shirt.

When we want from the Holiday Inn in Barbados to the heart of town by taxi Hernan told the taxi driver to stop in front of a side-atreet near the wharf. He got out of the taxi, went up to the edge of the wherf and threw something in the sea.

I have read the above statement and I have been told that I can correct, elter or add anything that I wish. This statement is true. I have made it of my own free will.
