CARLOS RODRIGUEZ QUESADA, Coordinator General. Ex-Secretary General of the Cuban Confederation of Labor in the Province of Las Villas. Ex-National Director of the sugar workers. Fought in the mountains with the Rebel Army. Rank of Captain. Known anti-Communist.

Dr. ESTEBAN FERRER, Secretary General. He represented important corporations in Cuba in the areas of sugar, metallurgy, drugs, liquor, iron, etc.

Dr. DENIO ODOARDO FONSECA, Chief of Underground and Foreign Affairs. He is a medical doctor, held the chair of Clinical Medicine at the University of Havana Medical School, was Chief of the Medical Department of School and Charity Kitchens, from 1959 to February, 1960, when he resigned because he disliked the Communist system. Ex-Chief of resistance under the July 26th Movement.

ARTURO GONZALEZ GONZALEZ, Chief of Supplies and Naval Affairs. Member of the Revolutionary Directorate in 1930. Agricultural industrialist. Ex-fighter in the Rebel Army in the Escambray and Las Villas. Ex-provincial leader of the July 26th Movement during the fight against BATISTA, assigned to Las Villas Province. Ex-General Superintendent of the Central University at Las Villas.

Dr. ROBERTO ARMAND BORREGO, Organizing Secretary. Economics specialist. Consulting lawyer to the Ministry of Treasury in Cuba. Member of the Student Revolutionary Directorate in the fight against BATISTA's dictatorship.

Dr. MARIO CASO ALVAREZ, Secretary for Meetings and Correspondence, ex-delegate from the sugar industry on the board of the Maternity Clinic in Las Villas, which was set up after the fall of BATISTA. Ex-legal adviser to eleven engineers located in that province, and ex-member of the Executive Board of the Managers' Confederation of Cuba. Specialist in sugar problems.

Dr. MARIO J. FERNANDEZ Y FERNANDEZ, Secretary of the Juridical Commission. Member of the Student Revolutionary Directorate in 1930 in Matanzas. Ex-professor in the Normal School in Matanzas Province; signer of the public manifesto against the tyranny of GERARDO MACHADO in 1931; imprisoned for conspiring in 1931 against the dictatorship, and condemned to prison in Santa Clara by the military authorities of Matanzas. Was pardoned in 1932 and arrested again immediately. He was imprisoned in San Severino, La Cabana, El Principe or the Isle of Pines for a year. Upon the fall of MACHADO's dictatorship, he was named prosecuting attorney in Santa Clara, until 1937, at the time of the first dictatorship of General BATISTA. He was replaced again by Dr. RAMON GRAU SAN MARTIN as Prosecuting Attorney for Matanzas Province in 1945, and remained in that position until 1955, when BATISTA's second dictatorship began. He was removed because of his request that the laws and the Constitution be obeyed, and also because he helped the revolutionary groups fighting against this dictatorship. He was appointed Attorney General of the Republic on February 5, 1959. He filled this position so well that he was congratulated by the Department of the Treasury in Washington for his work in breaking up international gangsterism. He resigned from this position on July 18, 1959, after FIDEL CASTRO had removed President MANUEL URRUTIA LLEO the previous day.

Dr. ALFREDO EMILIO RAMOS, Cultural Secretary. Dental Surgeon, holds a doctorate in pedagogy, as well as philosophy and letters. Ex-professor at the Central University of Las Villas. Ex-director of the Normal School in Santa Clara.

ENRIQUE VIDAURRETA, civil engineer. Planning Secretary. Ex-Chief of the Eastern District for Public Works, Las Villas Province. Specialist in highways and feeder roads. Ex-member of the July 26th Movement.

Mr. JUAN MARTINEZ LOPEZ, Secretary of the Student Section. Medical student, student leader, and ex-captain in the Rebel Army.

ISIDRO VALDES TORRES, Information and Intelligence Secretary. Ex-investigator for the Rebel Army and the Revolutionary Police. Ex-member of the July 26th Movement.

TOMAS ARENCIBIA SOTOLONGO, Secretary for Military Affairs. Ex-captain of the Rebel Army; ex-member of the July 26th Movement. Seriously wounded in the Uruguayan Embassy at the time when he took political asylum there.

ALBERTO ALCAZAR GARCIA, Secretary of the Revolutionary Youth Movement. A student of agronomy at Havana University. Ex-member of the July 26th Movement. Ex-inspector of the Ministry of Agriculture.

Dr. RAFAEL AGUILA, Secretary General for Industry. Lawyer, notary, rancher. Expert on sugar affairs.

JUAN FRANCISCO TAPIA, Secretary of Professional Section. Public Accountant. Ex-member of the July 26th Movement. Ex-technician of the National Bank of Cuba.

Dr. LUIS GUTIERREZ DELGADO, Press and Propaganda Secretary, journalist, lawyer, ex-editor of the literary page of "Diario de la Marina," in Cuba.

Dr. JOSE NICKSE, Secretary for Social Welfare. Medical doctor, surgeon. Ex-member of July 26th Movement.

JOAQUIN DIAZ ALVAREZ, Secretary of Foreign Commerce. Businessman, ex-member of the July 26th Movement.

President of the United States in Spanish, a transla-
tion of which is set forth below:

A Nuestros Compatriotas

Largos años de intensa lucha, meses de angustia implorando, tocando todas las puertas en busca de un camino que conduzca a la libertad de nuestro pueblo, han tropezado siempre con el frío valladar de la política Internacional, donde los cálculos e intereses ahogan los ayes de dolor de los hombres, mujeres y niños que agonizan bajo el horror del régimen comunista.

Lección difícil de aprender, pero que el tiempo transcurrido, nos enseña a los que no nos resignamos a sentir escapar el flúido vital de nuestra Patria sin un tratamiento urgente e inmediato que lo impida.

Mirando hacia atrás encontramos las mil ocasiones en que nuestro amor a Cuba ha sido juguete de la madeja Internacional. Las organizaciones más aguerridas, han sido mantenidas en inactividad mediante promesas oficiales hechas por "nuestros contactos" y que nunca alcanzaron la realidad. Recopilando toda nuestra paciencia, siempre abrigamos la esperanza que la última conversación era la positiva y que de ella surgirían como de una fuente mágica los recursos militares que permitirían al cubano transformar su angustia y dolor en acción directa contra nuestro único enemigo: EL COMUNISMO INTERNACIONAL.

Es necesario un alto y reflexionar, tenemos que comprender la naturaleza de las fuerzas que manejan nuestra batalla, el cubano necesita aprender que la sangre y las lágrimas de nuestro Pueblo no es combustible suficiente para mover el engranaje internacional como se demuestra claramente con el largo y muy conocido calvario vivido, sin más reacción por parte de las fuerzas que deben ser aliadas, que la pena ante el cadáver del pueblo más hermoso y envidiado de América Latina.

Inclusive, se puede demostrar perfectamente que no somos los cubanos los reales causantes de nuestra fragmentación. Ha existido el interés manifiesto, y no solo del comunismo internacional, de mantener divididas nuestras fuerzas alentando falsos líderes, hombres impuestos, que solo han pretendido que se eche a un lado la soberanía nacional que todos defendemos.

¿Porqué interesa la fragmentación de la fuerza cubana? Fácil resulta la respuesta: dice el viejo proverbio "Que en la unión está la fuerza" y todos estamos de acuerdo en pensar que la madeja Internacional no hubiera tenido otra alternativa que actuar y respetar en sentido favorable a un bloque monolítico del exilio, exigiendo con sobradísimos argumentos legales, políticos y humanos la libertad inmediata de nuestro pueblo.

Si los cubanos cerramos filas y envolvemos en una gran bandera cubana a los trescientos mil compatriotas en el exilio, ninguna fuerza política se permitiría la oportunidad de utilizar nuestra sentida causa en favor de intereses personales o particulares y al mismo tiempo, ense-

ñaríamos al mundo libre la firmeza de nuestras convicciones democráticas y lo que es mejor aún, la tónica de actividad en defensa de la sagrada libertad del hombre.

La creación inmediata de un Organismo representativo de todos los cubanos en el exilio es urgente, si de verdad queremos servir a Cuba. Un Organismo muy respetuoso, pero muy respetado, producto de la autodeterminación de los cubanos en el exilio, quienes en el uso de su libérrima voluntad, designan sus elementos representativos. Un organismo integrado por cubanos, hecho por cubanos, representativo de nuestro pueblo y por tanto, con planteamientos concretos y a tono con la problemática actual y ajeno totalmente a la ingerencia desorientadora "de contactos oficiales" u "hombres fuertes" que hasta hoy mismo han manejado a su antojo las ansias infinitas de recuperar su libertad a los cubanos en el exilio. Un Organismo que informe a las Naciones del Mundo Libre las decisiones cubanas, que abra sus brazos a los aliados y cale bayoneta contra los enemigos que se oponen al logro de nuestra sagrada meta: LA LIBERTAD DE CUBA Y EL IMPERIO DE NUESTRA SOBERANIA NACIONAL.

Invitamos a todos nuestros compatriotas a reflexionar, a serenar nuestro espíritu y poner en juego la inteligencia y capacidad de nuestro pueblo.

Que cada hombre ocupe su puesto en el combate, ya que no hay excusa que justifique el aislamiento de todo aquel que tuvo el alto honor de nacer en la Patria de Martí. La responsabilidad no radica en las Organizaciones revolucionarias o Profesionales; el pesado fardo de la lucha por la reconquista de la libertad descansa fundamentalmente sobre los hombros de cada cubano. Es la conducta de cada uno de nosotros la que determinará nuestro futuro.

Cada cubano que se incorpore a la lucha activa, es un eslabón más que fortalece e impulsa nuestras decisiones. Enseñemos al Continente que no solo conocemos la democracia sino que asimismo sabemos ejercitarla y defenderla y, sobre todo, que por su propia decisión, los cubanos estamos dispuestos a luchar contra todo lo que se oponga a nuestro regreso. Que no salimos de Cuba a continuar nuestra vida, sino con el firme propósito de entregarla si es preciso por la paz de nuestra tierra.

Hacemos formal llamamiento a las Organizaciones revolucionarias y a los cubanos en general para que patrióticamente y disciplinadamente se incorporen a la lucha con una sola meta: REGRESO A CUBA EN 1963.

Na te resignes cubano a que otros determinen el futuro de tu Patria! Recuerda que tienes el derecho y el deber de decidir las cuestiones vitales que te atañen.

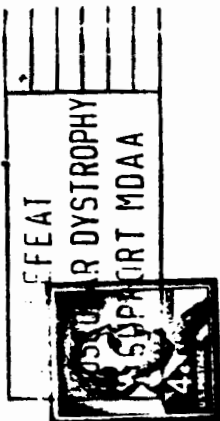
