SUBJECT INFORMATION

Subject information, including birth data, aliases, or nicknames, residential, physical description, medical or psychological history, education and employment data are retained in the SLATTERY ASSOCIATES, INC. original notepack. These records, if required, are available to the sponsoring agency upon request.

Subject information, deemed worthy of comment, if any, is included in Section VI of this report.

II

EXAMINER INFORMATION

The examinations were conducted by George B. Slattery, licensed by the State of Florida, license number 104-P, expires June 30, 1977, of SLATTERY ASSOCIATES, INC.

This examiner has been practicing since 1962 and has conducted numerous examinations regarding criminal and civil case investigations, which include major crime cases for the Dade County State Attorney's office and Public Defender's office.

This examiner has been qualified as an expert witness in the Florida Court system.

III

POLYGRAPH INSTRUMENT INFORMATION

The instrument used for the examinations was a Stoelting Portable Deceptograph, model n-mber 22500, utilizing at least three pens for simultaneous, permanent and visual recordings of the subject's blood pressure, pulse, respiration and galvanic skin response.

VI

POLYGRAPH TECHNIQUE

The BACKSTER ZONE COMPARISON TEHCHIQUE was atilized for the examinations. Portinent (red zone) questions only, and the subject's responses are listed in Section VII of this report.

CASE INFORMATION

Case information was provided by Detective Fabio Alonso of the Dade County Public Safety Department and included; a) a 14 page summary report dated June 14 & 15, 1976, b) a 20 page statement of Willie Salon re NIEVES dated February 21, 1975, c) summary chart of the various homicides and d) related police reports of the homicides and jerimes in issue.

RE: Homicide of LUCIANO NIEVES; which occured at approximately 12:45 PM, on February 21, 1975, in the parking lot of Variety Childrens Hospital, 6125 Southwest 31st Street, Miami, Dade County, Florida.

Salon stated that in late November-December of 1974, he, VALENTIN HERNANDEZ, JESUS LAZO, EDUARDO CLADEL, RAFAEL PEREZ, JCSE PATRICIO JOSE ELIAS, RAUL HERNANDEZ and WILLIE CALVINO were all part of an organized group who discussed and planned the homicide of NIEVES. In December, 1974, Salon, HECTOR CARBONELL and VALENTIN HERNANDEZ were in a beige Plymouth, (previousely purchased by JESUS CARTAS and made to look like a police car) driven by Salon, surveiling Nieves' house. Nieves drove away from his house, Salon armed with a .45 caliber pistol drove after him, Valentin Hernandez, armed with a sawed off shotgun was sitting next to Salon in the passenge seat and Carbonell, armed with a silencer equipped M-3 sub machine gun was in the back seat.

Salon was supposed to stop or slow down Nieves' car using the blue police light and siron and Hernandez and Carbonell were to shoot and kill Nieves. Their plan failed when Nieves drove through a traffic light that just turned red and Salon observed a marked police car at the intersection. They lost sight of Nieves' vehcil and Salon and Hernandez returned to the area of Nieves' residence where they waited for several hours.

Salon allegedly decided after that night that he did not want to take part in killing Nieves. Salon alleged that the balance of t orginal group did continue the surveillance and they planned abduction or murder of Nieves.

Salon further stated that on the afternoon of February 21, 1975, while at his parents house where he was living, he received a telephone call from Valentin Hernandez, who told Salon that som thing had happened and to stay at home. He subsequently left his parents house and went to the jewelry store, owned by ENRIQUE VELASCO. In a conversation with Velasco at his store Velasco to Salon that Valentin Hernandez and Jesus Lazo had just shot and killed Luciano Nieves at Childrens Variety Hospital and that bot men were hiding in Velasco's house at that time.

Salon and Velasco went to a pharmacy around the corner from the jewelry store and picked up perscription medicine to treat Vale Hernandez who had been wounded during the Nieves shooting. The

subsequently arrived at Velasco's house and Salon saw Jesus Lazo and Valentin Hernandez who was lying on a bed with his hand wrapped up.

Salon subsequently left Velascos house, with Velasco, to get Jasus Lazo's white Volkswagen which Lazo and Hernandez had abandoned in the area of the hospital after the shooting. He, JOSE LEWIS, who had keys and LUCIE and a male named LAZARUS (the sister and brother-in-law of Jesus Lazo) located the Volkswagen and Lazarus drove the car to the apartment in which he and Lucie lived.

Salon later returned to Valesco's house and while there, Valentin Hernandez and Jesus Lazo both told him of the Nieves shooting at the hospital. Valentin told Salon that Valentines wife, SYLVIA, saw Nieves at the hospital and called Valentin. Valentin called Jesus Lazo who picked him up and they drove to the hospital in Lazo's Volkswagen. Valentin scuffeled with Nieves in the parking lot and Valentin lost a pair of eyeglasses that he borrowed from Velasco and a toupee.

Valentin said that he drew his (.330) pistol and tired to shoot Nieves but his gun jammed. Jesus Lazo drew his .45 caliber pistol and shot Nieves at point blank range. Valentin, still holding Nieves, was shot in the right index finger by Jesus Lazo as Lazo was shooting Nieves.

While Salon and Hector Carbonell were by the Valesco house, HECTOR CARBONELL contacted DOCTOR CARLOS GARRIDO and he and Carbonell subsequently drove to the area of S.W. 62nd Avenue and 38th Street where they picked the doctor up at his residence and drove him to Valesco's house. The doctor, reportedly a resident at Baptist Hospital, was made aware of Valentin's gunshot wound, supposedly accidental, and treated the wound. Doctor Garrido wrote a prescreption and gave advice as to how to treat the wound. After treating Valentin the doctor was taken back home by Salon and Carbonell.

Also on the day Nieves was shot, Valentin Hernandez told Salon the had thrown the murder weapon into a canal after fleeing from scene. Salon saw a .45 caliber pistol clip in Lazo's Volkswage after Lazarus drove the car to his apartment.

EXAMINATION ISSUES

Detective Alonso requested that his examiner attempt to verify previousely detailed information via the polygraph technique. -- was also requested that Salon be asked if he took any part in Nieves homicide.

SUBJECT'S VERSION OF THE INCIDENT

Before discussing the matter with Salon, he was advised of this Constitutional Rights, re Hiranda. He then read and signed a rights waiver form, a copy of which is included at the end of this report.

The previousely listed Basic Case Information was read to Salon by this examiner and he agreed that the same was essentially true and correct.

Salon stated that he took no part in the shooting death of Nieves He explained that the reason he had previousely extricated himself from the conspiracy to kill Nieves was because he did not feel secure in the methods being employed by other in the group. He did not have any confidence in Valentin Hernandez and feared that the people involved may possibly be caught because the entire operation had become less than well planned and coordinates

POR TOWN THE RESULTS AND CONCLUSIONS

Based upon a careful analysis of Salon's polygrams, it was the opinion of this examiner that there were physiological reactions indicative of deception in the areas of his responses to some of the relevant test questions.

Therefore, it was the opinion of this examiner that Salon had taken a direct part in the Nieves homicide and that he was deliberately withholding information about the homicide.

Based upon the particular areas of apparent deception this examiner believed that, (a) Salon was not at his parents home at the time Nieves was shot and killed, (b) Salon was the person who called Valentin Hernandez and told him that Nieves was at the hospital, (c) Salon helped, or set up the Nieves homicide on February 21, 1975 and (d) Salon vitnesses the Nieves homicide.

This examiner, after an analysis of Salons six polygrams noted these opinions on a legal pad in a manner so as to conceal said notes from Salon. Salon was then advised that in my opinion he had lied in answering SOME of the previousely listed relevant test questions.

Salon subsequently admitted that he had lied to this examiner.

He said that on the morning of February 21, 1975, he had been surveiling the Neives residence and trying to locate Nieves. He subsequently did locate Nieves at the hospital and called Hernandez Valentin Hernandez advised Salon to stay at the hospital and that he would try to get Jesus Lazo to drive him there. Salon subsequen saw Valentin Hernandez and Jesus Lazo drive to the hospital, around the block and then into the hospital parking lot. He saw Hernandez hit Nieves on the head or face with his gun, heard shouting, saw Hernandez aim his gun at Nieves but heard no shot and saw Lazo shoot Nieves.

Salon said that Nieves was getting into his blue Dodge Dart and was wearing a suit when he was killed by Lazo and Hernandez. Salor also said that after the shooting people started coming out to see what was happening so he left his "strategic position", got into his car and left the area.

After relating this account of his involvement to this examiner, twice, and to Detective Fabio Alonso, Salon stated that this account was not true; that his original version of no personal involvement was true and correct. Assistant State Attorney Edward O'Donnell was contacted and the polygraph interview was terminated.

Dear Mr. O'Donnell:

On July 23, 1976, William Salon was administered a polygraph examination regarding the First Degree Murder of LUCIANO NIEVES on February 21, 1975.

Basic case information, as reviewed with you, Detective Alonso, and Attorney Denaro, is contained in my previous report of June 25, 1976. The relevant (red zone) examination questions and subject's responses were as follows:

1. Chart I

- 39. Regarding the Nieves homicide, do you intend to answer truthfully each question about that?
- (A.) Yes.
- 33. On the day that Luciano Nieves was killed, did you personally see him at Variety Children's Hospital?
- (A.) No.
- 35. On the day Luciano Nieves was killed, had you told Valentin Hernandez that Nieves was at the hospital?
- (A.) No.

2. Chart II

- All red zone questions and the subjects responses were the same as those in Chart I, except the order of questions 33 and 35 were reversed and 37 added.
- 37. On the day Nieves was killed, had you told Jesus Laso that Nieves was at this hospital?

3. Chart III

- 39. Regarding the Nieves homicide, do you intend to answer truthfully each question about that?
- (A.) Yes.
- 45.3-On the day Nieves was killed were you at Variety Childrens Hospital?
- (A.) No.
- 45.K-Did you see Nieves get shot and killed?
- (A.) No.
- 45.L-On the day Nieves was killed had you told Laso or Hernandez that Nieves was at Variety Childrens Rospital?
- (A.) No.
- 4. Chart IV

All red zone questions and the subject's responses were the ... same as those in Chart III, except the order of the questions was changed.

RESULTS AND CONCLUSIONS

Based upon a careful analysis of Salon's polygrams, it is the opinic of this examiner that there were no physiological reactions, indicatof deception, in the areas of his responses to the pertinent test questions.

It is therefore the opinion of this examiner that Salon; a) did not see the victim at Variety Children's Hospital on the day he was killed, b) did not tell Hernandez or Laso that Nieves was at the hospital before he was killed, and c) that Salon did not see Nieves get shot and killed.
