SYNOPSIS:

On 30 March 1977 FBI Agent Sy Gutierrez contacted this writer and advised that GUSTAVO CASTILLO had held a party at his home on 29 March 1977 to celebrate his success at being found not guilty in court on charges of bombing the University of Miami on 3 April 1976.

DETAILS:

Gutierrez advised that present at the party were EVI VIDANA of ABDALA, RAFAEL VILLAVERDE, RICARDO MORALES NAVARRETE, and RAMON OROZCO along with FRANK CASTRO.

On 30 March 1977 Det. E. Mederos contacted RAFAEL VILLAVERDE, who then related that present at the party were EVI VIDANA, JUAN RODRIGUEZ, himself (VILLAVERDE), and attorneys for CASTILLO, JERRY WIENER and SID SHERES. VILLAVERDE denied that OROZCO or MORALES had attended.
