

Investigation into the activities of Gustavo Castillo.

The following statement was taken at the Dade County Public Safety Department Building, 1320 N. W. 14 Street, Miami, Dade County, Florida, on Thursday, 19 May 1977, commencing at 2:37 p.m. in the presence of Detective D. Benitez. Recorded and transcribed by Steno-Reporter and Notary Public Joan Weisberg.

(The reupon, <u>PAVID FRE IFELDER</u> was duly sworn according to law.)

Q (By Detective Benitez) For the record, investigation into the activities of Pablo Gustavo Castillo occurring on Saturday, 14 May 1977, at the Dade County Jail.

Sir, would you state your name please?

A I'm Sergeant David Freifelder.

Q Okay. What is your occupation?

A I'm attached Correction and Rehabilitations
Manager. I'm a fourth floor team leader.

Q Sir, what is your business phone?

A My business phone is 547-7384.

Q Okay, sir. I'm asking you here to ask you questions in reference to an incident that occurred on Saturday, 14th of May of 1977. One of the persons involved in that incident was a man by the name of Pablo Gustavo Castillo. Could you please relate to me more or less what happened in your involvement in it?

A My involvement. Officer George Malvestuto assigned to the second floor, Chapel area of the jail, came to me after church services and stated that he had—that he had taken notice of a visitor approached by Chaplain Perez by the name of Gustavo Castillo whom he recognized as a former inmate of the second floor at the Dade County Jail at some previous time. He notice that he was in earnest conversation for the best part of the chapel service with the exception of the times that he arose to sing.

When he came back, he instantly reentered into conversation with an inmate assigned to my floor, Cell Number 432, by the name of Delacova, 20-e-l-a-c-o-v-a, I believe. That's his last name. I'm not aware of his first name, but he's been at that cell since he has been back to testify to the Grand Jury.

Q Okay, sir. When Officer Mal-- What is his name?

A Malvestuto.

Q Malvestuto asked you to intervene in the incident

what did you do?

A I suggested that we talk to Delacova to see if he was aware who Castillo was. Officer Malvestuto and myself went to the perimeter of Cell Number 4 2 and entered into a conversation with inmate Delacova. Delacova-- Myself here speaking, David Freifelder here speaking-- "Do you know an inmate--" Not an inmate, but, "Do you know an inmate that you were talking to by the name of Castillo?" Delacova stated, "I don't know him. I also told the Grand Jury I don't know him." I felt that that was enough to identify that something wasn't proper.

I suggested to Officer Malvestuto that he write the incident in his own handwriting and I would take him to Lieutenant W. R. Smith, who was Shift Commander at the Jail at that time, as it would have to be his incident if this thing went any further.

Q Okay. Sir, did it go any further?

A A short time later, Officer Malvestuto with his handwritten report and myself went to Lieutenant Smith and explained the circumstances to him. Lieutenant Smith stated, "What did we wish to do?" I stated that I felt it should be brought to Captain Green of the supervisors of the jail when he returned on duty. Lieutenant Smith advised me that he would do so.

Q Okay, sir. Sir, you are a supervisor of the

Dade County Jail. That is correct?

A That is correct. I'm Correctional Officer III,

also known as Sergeant.

Q Okay, Sergeant. To the best of your recollection, is there any specific criteria for picking or allowing a person to come into the Dade County Jail?

A Security must be maintained at all times.

Q Is there any set pattern or S. O. P.'s instituted for bringing in of people on this church group?

A They must all be qualified for my Chaplain Perez.


Q Okay, sir.

A Unless they were Ministers, we have a list of the Ministers that are allowed to enter the jail.

Q Okay. As far as you know, did Mr. Castillo appear on the list as a Minister?

A No.

Q Okay. As far as you know did Mr. Perez allow Mr. Castillo to come up in the jail?



A That's correct, he did.

Q Okay. All right. Now, I'm referring to Tuesday, I believe it was the 17th.

A That's correct.

Q This week. Did I contact you at that time in reference to this incident?

A Yes, sir. I was on duty and I met you in the Captain's office.

Q Okay. Did you basically relate to me what you related now?

A That's correct.

Q Okay. I have here a page that I'm showing you for identification. It's dated the 14th of May, 1977, and it's signed, initialed by me and initialed by Sergeant Freifelder. Sir, are these the notations you made on that page?

A That's correct. I made a copy of the original.

I put my badge number, name, date, and time there; 1500 hours.

Q Sir, do you see a name here, Gustavo Castillo?
A That's correct. Where the letter X appears on

Q Okay, thank you very much. Okay. After that, have you discussed this incident with anybody else?

A No, I have not.

Q Okay. Have you been approached by any of the attorneys, investigators, or Mr. Castillo, himself, in reference to this incident?

A No, I have not:

* Q Have you been approached by Mr. Delacova in regards to this incident?

A No, I have not.

Q Now, could you go into a little bit of detail and tell me more or less to the best of your recollection what transpired when you asked Delacova, the words he used--if not, try to maintain the meaning of what he was saying, if you can do that?

A When I asked him if he knew Castillo Gustavo, and he stated that he had met him in church and that the Grand Jury had also asked him if he knew <u>Gustavo Castillo</u>. I felt that I did not want to delve into Grand Jury business.

So at that time, you stopped the questioning?

A I stopped the questioning.

Q Did Mr. Delacova answer in the positive that he had spoken to Mr. Castillo?

A That's correct. He-- I did not ask him what he had said. I merely wanted to know if he had been in a long conversation with Castillo Gustavo, which he answered to in the affirmative

Q Okay. Did he say anything else or offer anything else after you assisted in the interrogation of him?

A No. He did not. I felt to say anything more might make him suspicious or positively interfere in some case that might be going on which we had no business entering into.

Q Okay, Sergeant. Is there anything else that I haven't asked you that you feel might be pertinent in the investigation that you want to comment on?

A I would like to comment on the fact that Officer Sharon, S-h-a-r-o-n Wims had refused admittance to Gustavo Castillo due to the fact that he is not on the church list and in this manner it was brought to Officer Malvestuto's attention and Malvestuto advised Chaplain Perez that there was a white male who desired admittance into the jail and stated that Chaplain Perez would okay it. At the same time, Sharon Wims had a man and a wife identifying themselves as Ministers whom she did not know. And as I understand it from listening to Officer Malvestuto and Officer Wims, Chaplain Perez presided from the second floor to the main lobby of the jail, identified the people, had them sign in, which is in line four of the same sheet, identified as being a true copy and at that time, he escorted them to the second floor of the jail which is the chaplain area.

Q Okay, sir, thank you very much. While we're still on the record, I would like to advise you to keep this investigation confidential and also, with the exception of your supervisor, Captain Green, I'm going to advise him of what's going on and advise you also that if you have any contact with Mr. Castillo in the future that you contact my office. You have our phone number.

A I shall do that.

Q Okay. Thank you very much.

(Thereupon, the statement was concluded at 2:49 p.m.)
