#### Scope and Content Note

The papers of Pierre Gustave Toutant Beauregard (1818-1893), Confederate Army officer, engineer, railroad official, and public official, consist of a diary (1847), correspondence (largely letterbook copies of letters sent), military papers (headquarters records, letterbooks, telegram books, reports, order books, endorsement books, and other records), the autograph manuscript of "Reminiscences" (the basis for Alfred Roman's The Military Operation of General Beauregard, 1884), and scrapbooks. The papers span the years from 1844 to 1883 with all but a few items dated during or concerning the Civil War.

The few early items in the collection relate to Beauregard's career as an engineer in New Orleans and on the staff of Gen. Winfield Scott in Mexico, where Beauregard took part in the siege of Vera Cruz and the battles of Cerro Gordo, Contreras, and Mexico City. The bulk of the correspondence, the military papers, and the "Reminiscences" relate to Beauregard's service as a general officer of the Confederate Army. He was in command of the troops at Charleston, S.C., when the Civil War began with the siege of Fort Sumter. His role in the battles of 1st Manassas and Shiloh, in the siege of Corinth, Charleston, and Petersburg, and finally in the consolidation of southern forces after the battle of Atlanta is fully documented in the papers.

Material on Beauregard's career as railroad and public official in New Orleans, and supervisor of the Louisiana lottery, can be found in a half-dozen letterbooks. The three volumes of scrapbooks of newspaper clippings are devoted almost exclusively to personal clippings of the Civil War.
