GENERAL ORDERS.) HEAD-QUARTERS, DEP'T OF S. C., GA., AND FLA., ... CHARLESTON, S. C., March 31, 1863.

I. Before a General Court Martial, convened at Charleston, S. C. by virtue of General Orders, No. 30, current series from these Headquarters, dated February 19, 1863, of which Lieutenant-Colonel W. A. DANIELS was President, were arraigned and tried:

1. Private J. B Mitchell, Company C, 8th Battalion Ga. Vols.

CHARGE I.

Disobedience of Orders. 3

Specification In this; "That the said Private John B. Milchell, Company C, 8th Ga. Battalion Infantry, P. A. C. S., did, on pr about the 7th day of February, 1863, at Secessionville, S. C., refuse to answer to his name at roll call."

CHARGE II.

Gross and insulting language to the first sergeant.

Specification In this; "That he, the said J. B. Mitchell, Company C, 8th Ga, Battalion Infantry, P. A. C. S., did, on or about the 7th day of February, 1863, when his name was called, did answer, 'Here is your regular detailed battery guard, damin you.' The said John B. Mitchell did answer thus at three successive roll calls with the bitterest contempt." All this at or near Secessionville, S. C.

To which the accused pleaded as follows:

... To the Specification of 1st Charge: " Not Guilty."

To the Specification of 2d CHARGE; "Not Guilty."

To the 2d CHARGE: "Not Guilty."

FINDINGS AND SENTENCE.

The Court after mature deliberation, finds the accused as follows:

Of the Specification of 1st CHARGE: "Guilty."

Of the 1st Charge: "Guilty."

Of the Specification of 2d CHARGE: "Guilty of so much as charges, 'In this: that he, the said John B. Mitchell. Company C, 8th Ga. Battalion, did, on or about the 7th day of February, 1863 when his name was called answer, 'Here is your regular battery guard, damn you. The said John B. Mitchell did answer thus with contempt. All this at or near Secessionville, S. C.". And of the rest of the Specification, "Not Guilty."

Of the 2d Charge; "Guilty."

And the Court does, therefore, sentence the said Private D. E. Daris, of Company D, 46th Regiment G. V., P. A. C, S., "to forfeit to the Confederate States his pay for one month, and to be confined under charge of the guard at his camp for the space of one week."

25. Sergeant A. Page, Company C, Siege Train. P. A. C. S.

Absence without leave.

Specification In this; "That he, the said Sergeant A. Poge, Company C. Siege Train. P. A. C. S., did, without leave from his commanding officer. absent himself from the camp of his company at Race-course near Charleston, S. C., on the 17th day of February, 1863, and did remain absent until the 24th day of February, 1863." All this at camp of Siege Train, Race-course, near Charleston, S. C., February 24, 1863.

. To which the accused pleaded as follows:

To the Specification : " Not Guilty."

To the CHARGE: "Not Guilty."

FINDINGS AND SENTENCE.

The Court, after mature deliberation finds the accused as follows:

Of the Specification: "Guilty."

Of the Charge: "Guilty."

And the Court does, therefore, sentence the said Sorgeant A. Page, Company C. Siege Train. P. A. C S., "to be reduced to the ranks."

26. Private Ed. S. Rodley, Company C, Lucas' battalion S. C. Artil-

Desertion.

Specification In this; "That he, the said Ed. S. Rodley private, Company C, Lucas' battalion Artillery, P. A. C. S., did, on or about the 27th day of June, 1862, desert from his company and remain away until arrested in Charleston, S. C., on or about the 26th day of January, 1863." All this at Charleston, S. C., between the 27th day of June, 1862, and the 25th day of January, . . .

To which the accused pleaded as follows:

. To the Specification: "Not Guilty, but guilty of absence without leave." * ** * : .

To the CHARGE: "Not Guilty."

FINDINGS AND SENTENCE.

The Court, after mature deliberation, finds the accused as follows:

Of the Specification: "Guilty."

Of the CHARGE : "Guilty."

And the Court does therefore sentence the said Private Edward S. Rodley, Company C, Lucas' battalion P. A. C. S., "to be shot to death with musketry (twothirds of the Court herein concurring), at such time and place as the Commanding General may direct."

27. Private G. W. Wilson, Company C, Lucas' battalion.

Specification In this: "That he, the said G. W. Wilson, private, Company C, Lucas' battalion Artillery, P. A. C. S., did, on or about the 18th day of Sep. tember, 1862, desert from his company and remain absent until arrested in Savannah, Ga., by Sergeant Thomas Delahaunty, Company C, Lucas' battalion Artillery, P. A. C. S., on or about the 11th day of February, 1863.25 All this at Fort Pemberton and Savannah, Ga., between the 18th day of September, 1862, and the 11th day of February, 1863.

To which the accused pleaded as follows:

To the Specification: "Not Guilty."

To the CHARGE: "Not Guilty."

28. Private B. Temples, Company K, 46th Regiment Ga. Vols.

Conduct prejudicial to good order and military discipline.

Specification 1st In this; "That the said Private B. Temples, of Company K. 46th Regiment Ga. Vols., P. A. C. S., when ordered by the sergeant in charge to police the camp, refused, and failed to do his full duty, and did, thereupon, quit the camp."

Specification 2d In this; "That the said Private B. Temples, of Company K. 46th Ga. Vols., P. A. C. S., positively refused and failed to go on guard when ordered by his commanding officer, viz: 1st Lieut, B. H. Crawford, Company K. 46th Ga. Vols." All this at Spring Street battery, in the City of Charles ton. S. C., on the 2d and 3d days of March, 1863.

To which the accused pleaded as follows:

To the 1st Specification: "Not Guilty."

To the 2d Specification: "Not Guilty."

To the CHARGE: " Not Guilty."
