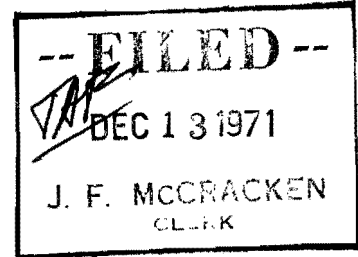

LOUIS REILLY

was called as a witness by the Defendant and, after having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. BOCZAR:

Q Would you state your name and official occupation, please?

A Louis Reilly, Sergeant of Police, Miami Beach, Florida.

Q Were you so employed on October 18th, 1968?

A Yes.

Q On October 18th, 1968, did you have an opportunity to go to the Air Canada Office at 6988 Collins Avenue, Miami Beach, Florida?

A I did.

Q Would you tell us what you did there, sir?

A We had a report of a bomb explosion there.

I went to the scene with Agent Irving

and there I saw that the Air Canada Office had suffered damage from some sort of an explosion.

We called the Dade County Sheriff's Office and asked for Captain Brody, who came to the scene and made his examination of the scene.

Q Did you do anything with the investigation of the scene?

A I stayed outside the Air Canada Office all the time.

Q Did you take any pictures of any damage?

A No, I didn't.

Q Or anything of that nature?

A No.

Q Did you do anything else with regard to the explosion ---

A I made an Offense Report.

Q (continuing) --- that took place at the Air Canada Office?

A I made an Offense Report for our files.

I didn't go into too much detail, only as to what I knew.

Q Had you ever met the Defendant, Hector

Cornillo Llano?

A. No.

MR. BOCZAR: I have no further questions.
