From this it will appear that the Board of Aldermen stands: Republicans, 10; Democrats, 12; Liberals, 3. If the Liberals join the Republicans they have a majority of one; if they go with the Democrats, the latter have a majority of five.

In the Board of Councilmen there is one seat not to be counted, there being a tie. In the other wards the Republicans number 25; Democrats, 21; Liberals, 3. This gives a clear majority of 1 to the Republicans, and of 4, if joined by the Liberals. If the tie in the Thirteenth Ward should result in the choice of a Democrat, it would make the board a tie. On joint ballot, counting the Thirteenth Ward Republican, the Council stands thus:

Republicans.....	86
Democrats.....	53
Liberals.....	6

From this it is apparent that the Liberals hold the balance of power. The new Council will be composed of 75 members, a majority of which is 37. Neither the Republicans nor the Democrats have so many votes; it is only by enlisting the Liberals that either party can effect anything.
