EXPLOSIVE AND INCENDIARY DEVICES

Continuing investigation by Elizabeth NJPD and Union County Prosecutor's Office negative to date. FBI Lab report revealed tool marks developed on evidence previously submitted and of value for comparison purposes. Identification Division, Latent Fingerprint Section advise specimens examined and no latent prints of value present or developed. On 3/12/75 provided to FBI Newark a device similar to one found at Town and Campus. This device was received by Newark PD on 11/10/74. Investigation by Newark PD developed no suspects or motives. Device forwarded to FBI Laboratory for examination. Results of examination of Newark device previously conducted by Hazardous Device Division, Redstone Arsenal, Huntsville, Alabama, set forth. ROLANDO MASFERRER Y ROJAS, well-known former Cuban senator and Cuban exile who recently completed a sentence in a Federal penetentiary, was contacted by SA telephonically, on March 3, 1975. ROLANDO MASFERRER currently resides at 1400 Southwest First Street, Miami, Florida, with telephone number 305-667-2132, and maintains an office at 2000 West Flagler Street, Miami, Florida, with telephone number 305-541-2367.

MASFERRER was telephonically contacted March 3, 1975, at his office, at which time his assistance was solicited relative to recent killings and bombings which have occurred in communities in Miami, Florida, and in the New York-New Jersey areas. It was requested of MASFERRER that this office was interested in obtaining identities of individuals responsible for recent bombings, including the bombing which occurred in Elizabeth, New Jersey, on February 11, 1975, and also the identity of individuals responsible for recent assasinations of Cuban exiles.

MASFERRER stated that according to information in his possession, those responsible for the events mentioned above are radical individuals from several Cuban exile organizations, and these individuals have sworn their allegiance to Dr. ORLANDO BOSCH of ACCION CUBANA (AC).

ACCION CUBANA (AC) is an Anti-Castro organization headquartered in Niami, Florida. This

organization has claimed credit for bombings in the past and is headed by Dr. ORLANDO BOSCH, who currently is a fugitive and is reported to be residing in Santiago, Chile.

MASFERRER stated that he currently is publishing a weekly newspaper and that several of the advertisers to this paper have received threats to stop advertising in MASFERRER's paper, and have one of the advertisers has already been physically beaten up, and one of MASFERRER's people have been beaten in Miami.

MASFERRER stated that he was willing to coperate fully, and that he would attempt, through his orgation, to obtain the desired information.
