

1 The reupon--2 GEORGE R. HAVENS 3 was called as a witness by the Defendant, and having 4 been first duly sworn, testified as follows: 5 DIRECT EXAMINATION 6 BY MR. JOSEFSBERG: 7 Q Please state your name and occupation. Α George R. Havens, Police Sergeant, Dade 8 9 County Public Safety Department. 10 Mr. Havens, in your capacity with the Q, Public Safety Department have you had occasion to be 11 12 the lead investigator and responsible for the case 13 that is the subject matter of these depositions? 14 Yes, sir. Α 15 Q When did this case first open on the 16 files of the Public Safety Department? 17 We have already determined --18 А This was on the 12th day of September 19 1972. 20 Q On Tuesday, September 12, 1972 did Mr. 21 Canto appear at your office after you received a phone 22 call from Special Agent George Davis of the FBI? 23 Α Yes, sir. 24 I did not receive the phone call;

Sergeant Oller received the phone call and at approxi-1 2 mately 1 o'clock p.m. Mr. Canto appeared at our office. 3 I was advised by Sergeant Vincent Oller 4 that the subject did not speak English and that he 5 would translate. 6 The call from Special Agent Davis of Q. 7 the FBI to the best of your knowledge was made that day 8 to Mr. Oller? 9 Yes, sir. А 10 The 1 o'clock appointment was pre-Q. arranged apparently by Mr. Davis? 11 I don't know the answer to that ques-12 А tion, sir. All I know is he appeared at my office at 13 14 1 o'clock. 15 Q Were you expecting him at 1? 16 Yes. А 17 Did Mr. Oller tell you that Canto would Q 18 be there at 1? 19 Yes. sir. Α 20 At that time was a statement taken from Q, 21 Mr. Canto? 22 Α An oral statement was taken. 23 Q What did he say? 24 Mr. Canto advised me and Sergeant Oller-Α

1	Q While you are talking, I want you to
2	feel free to refer to your notes to be as specific as
3	you can to what he said to you.
4	A Yes, sir.
5	Mr. Canto advised myself and Sergeant
6	Oller that on the 1st of September 1972, which would
7	have been a Friday, that he, Canto, received a tele-
8	phone call from a subject known to him as Ramon
9	Donestevez, and that he knew Mr. Donestevez because he
10	had purchased a boat from him, and that he had talked
11	to Mr. Donestevez many times.
12	Canto advised that Mr. Donestevez ad-
13	vised him he wanted him to come to his boat factory in
14	Perrine. It was called the Piranha Diesel Corporation.
15	Mr. Canto advised me that he believed
16	that Mr. Donestevez wished him to come to his boat
17	factory relative to a boat which had been manufactured
18	by Piranha Diesel, Mr. Donestevez, and had been reported
19	as stolen from Mr. Canto in the City of Miami.
20	He advised that he arrived at the boat
21	factory at approximately 9 p.m. and when he entered
22	the factory, that two men drew automatic pistols on
23	him, and that they set him down in the main office
24	area of Piranha Diesel sales, and that shortly thereafter

Mr. Donestevez entered the office wearing a pair of 1 green fatigues, boots -- he described him as being 2 dressed like Fidel Castro. He was wearing an auto-3 matic pistol. 4 He advised us that Mr. Donestevez told 5 him to sit down and that they were going to discuss 6 a trip which Canto was going to help him make to 7 Havana, Cuba. 8 At that point Canto advised Donestevez 9 told him that they wanted some money, they wanted him 10 to give them \$800. 11 He said he didn't have any money. At 12 that point Canto advised that Donestevez removed from 13 a wall a rifle, which he described as having a folding 14 stock. 15 He drew a picture of it, and it appeared 16 to be an AR 15, a fully automatic rifle. 17 Q. Have you retained that picture? 18 19 Α No, sir, he just drew a little sketch of what the rifle looked like. 20 We would ask him specific questions as 21 22 to the description of the rifle and he would say it had a long barrel, it had--basically he was describing 23 24 the rifle, and when it ended up, it appeared it would

be an AR 15 rifle. 1 He said it was an automatic, and he 2 described how you put a shell into the chamber. 3 He then advised at that point that the 4 other two subjects removed from him his watch, his 5 ring, an ID bracelet, and that they left and they went 6 7 outside the building. Shortly thereafter they returned inside 8 the building with a .38 caliber revolver which he had 9 in his car, a Rossi revolver. 10 At that point he advised that Donestevez 11 told him that he would have a specific amount of time 12 to procure the money, and if he didn't get the money, 13 that they were going to fill him full of lead. 14 Those were his words. 15 He said he was frightened, he was 16 afraid, and they told him he better not call the 17 police, and then he went home. 18 19 Will you continue to tell me what if Q. 20 anything he said to you additionally at the time of 21 this first interview on September 12th? 22 Yes, sir. I am referring to my notes. Α 23 if I might. 24 Mr. Canto advised us that he went to

the FBI to report this crime a day or two after it 1 happened, and that he was interviewed by FBI agents, 2 and that he was shown a group of photographs of people. 3 He knew Ramon Donestevez and he was 4 shown a group of people who allegedly associated or 5 worked for or were known to be with Donestevez. 6 He advised he picked out two pictures 7 as being the ones who were the ones who actually 8 pulled the guns on him at the boat factory. 9 One was Emelio Navarro and the other 10 was Ruiz Alfredo--Alfredo Ruiz. 11 That was the extent of his conversation 12 on the first date that he had at our office. 13 He told you that on September 2nd or Q 14 3rd he went to the FBI and advised them of extortion 15 and the violation of the neutrality laws of the United 16 States of America, and that he identified photographs 17 of three people who were the perpetrators of this 18 crime? 19 MR. TUNKEY: Objection. It calls for a legal 20 conclusion. 21 I instruct the witness not to answer. 22 23 MR. JOSEFSBERG: You are instructing him not 24 to answer?

MR. TUNKEY: Yes, sir, based upon that one 1 part of the question wherein you state there was a 2 violation of the Neutrality Act -- was that it? 3 4 (By Mr. Josefsberg) Did he tell you Q. that he told them that he was told this money was for 5 the purposes of invading Cuba? 6 Mr. Canto advised me that he went to the 7 А FBI office and that he talked to FBI agents, that he 8 was shown a group of photographs, two of which he 9 picked out as being the subjects, including Ramon 10 Donestevez who had robbed him at gunpoint. 11 12 And that is the extent of the information which I received from Mr. Canto relative to his inter-13 view at the FBI. 14 He never told you what he told them? 15 Q Did he just go in there and say "I would like to see 16 a photograph of three men I may have seen the other 17 day"? 18 19 Α He advised us that he went to No, sir. 20 the FBI to report that he had been robbed by three 21 people. 22 Did he tell you that he did not tell Q 23 them about the Cuban aspects of this? 24 Α No, sir, he didn't advise me of that.

1 MR. TUNKEY: Let the record reflect that 2 pursuant to Rule 4, Discovery, we are showing or going 3 to show Mr. Josefsberg those pictures which Sergeant 4 Havens has in his possession at this time. 5 MR. JOSEFSBERG: Let the record reflect that 6 Rule 4, Discovery, was due a long time ago, and I am 7 seeing them now but I have not been shown them or advised of them beforehand. 8 9 MR. TUNKEY: Let the record reflect that Mr. 10 Josefsberg has at no time made an appointment with me to inspect, copy or view any physical evidence. 11 This is the first opportunity that I 12 13 have had to show him these items, and I of course have 14 no objection at any time in the future reaching a 15 mutually agreeable time to view all of the evidence 16 in this case. 17 Then we will also put in the MR. JOSEFSBERG: 18 record a letter of October 6, 1972 requesting the 19 opportunity for such an appointment which was sent to 20 Mr. Tunkey. 21 Apparently he has been out of the 22 country since that time and his office hasn't even 23 bothered to reply to my letter, and that's right, I 24 have made no appointment because I left some messages

there and he told me he wasn't there and he never 1 replied to my letter. 2 But we will put a copy in the record 3 4 since you have raised the issue that I haven't made an 5 appointment. Do you have a copy? I see the October 6 6th letter right on top of your file. 7 MR. TUNKEY: Yes. 8 MR. JOSEFSBERG: Then it was received by 9 Is it stamped in? 10 your office. MR. TUNKEY: Yes. October 11th. 11 This is now October 24th. MR. JOSEFSBERG: 12 You have been out of the country since then, right? 13 MR. TUNKEY: No. that is not right; I have 14 15 been out of the State however. Are you finished with the photographs? 16 17 MR. JOSEFSBERG: No. 18 Are these photos being given to me pur-19 suant to Rule 4, or will copies be furnished later? 20 MR. TUNKEY: Rule 4 provides you may make 21 copies at your own expense. 22 MR. JOSEFSBERG: May I have them, and I will 23 make copies? 24 MR. TUNKEY: You may have them to make copies

when Sergeant Havens is able to do that. 1 I will make you copies of them. 2 THE WITNESS: MR. JOSEFSBERG: That is what I asked for. 3 4 MR. TUNKEY: That's fine. as I said I would do with all the other photographs. 5 MR. JOSEFSBERG: That's fine. 6 I said, will you make me copies? 7 MR. TUNKEY: Yes. 8 MR. JOSEFSBERG: You said no; you said you 9 would let memake them. 10 MR. TUNKEY: I said I wouldn't let you take 11 them. I don't think we need to quibble about this 12 though. 13 (By Mr. Josefsberg) When did you Q 14 15 receive those photographs from the FBI? The day that Mr. Canto came to my office. А 16 I believe Sergeant Oller had them in his possession. 17 18 Q Do you know how he received them? No, sir. 19 Α 20 Q. What if anything else did he tell you? "He." Mr. Canto? 21 Α 22 Yes. Q 23 А Only what I have related so far. 24 Q Did you make a report of what he had

2	A Yes, sir.
3	Q Have you since that time studied and
4	reread the report, and does it accurately reflect his
5	allegations as stated on September 12, 1972?
6	A Yes, sir.
7	Q What did you do after that?
8	A We began an investigation.
9	We took it upon ourselves to institute
10	an investigation. Mr. Canto then contacted Sergeant
11	Oller and advised him that he had received a letter in
12	the mail alleging that it wasit was demanding of some
13	money and threatening his life.
14	Sergeant Oller requested Mr. Canto
15	bring this letter to our office, which he did.
16	Q Sergeant, do you recall back on Septem-
17	ber 12th either you or Mr. Oller asking Mr. Canto if
18	he had received anything in writing from these people?
19	A No, sir.
20	Mr. Canto came to our office and advised
21	us that he had received a letter. The letter was
22	written in Spanish and he gave the letter to Sergeant
23	Oller.
24	Sergeant Oller translated the letter.

It was typewritten. The letter was dated 9/9/72. 1 That is the letter and envelope which Q 2 has been furnished to me with the State's Rule 4 3 compliance? 4 Yes, sir. 5 Α Have you since that time had the letter Q 6 and/or envelope dusted for fingerprints? 7 Α Yes, sir. 8 Q. Have you found any? 9 None of value, no, sir. Α 10 Have you compared the writing on the Q. 11 envelope or the typing on the letter with any known 12 typing or handwriting? 13 Yes, sir. 14 Α With whose? 15 Q We attempted during the execution of Α 16 a search warrant to recover a typewriter--there were 17 three in Mr. Donestevez' boat factory. 18 However those were apparently inopera-19 tive or hadn't been used for an extensive period of 20 time, primarily because of dust and cobwebs that were 21 22 on them. 23 One of them was inoperable, it didn't 24 work at all.

In other words, even without any exper-Q 1 tise you knew those couldn't be the typewriters in 2 question? 3 They didn't appear to be. I don't think Α 4 they could have been used in months, and the letter was 5 dated and postmarked on the 9th of September. 6 The only thing which I have that Mr. 7 Donestevez signed is a property receipt. His signature 8 is a big round circle with a long line. 9 Have you taken any handwriting exemplars Q. 10 from Mr. Canto? 11 From Mr. Canto? Α 12 Yes. Q. 13 No, sir, I have not. Α 14 Have you determined what type of type-Q. 15 writers he owns? 16 А No. sir. 17 Have you furnished any typing or hand-Q 18 writing specimens to any handwriting or typing expert? 19 А Yes, sir, I have sent them the letter. 20 However, we don't have the typewriter or standards to 21 22 compare with. 23 I don't have any of Mr. Donestevez' 24 handwriting, nor I don't have a typewriter which was

used allegedly to type this. 1 2 Nor have you sought any handwriting and Q. 3 typing from Mr. Canto, is that correct? 4 That's correct--well, no, that is not А 5 quite correct. 6 Ido have some banking records from Mr. 7 Canto, an application for a loan, but I don't see any necessity--I didn't feel and I still don't feel there 8 is any necessity to compare these against the handwrit 9 10 ing in the letter. Based on the subsequent investigation 11 and based on conversation which I overheard of a tape, 12 there is no doubt in my mind that Mr. Canto didn't 13 write these, he didn't do this. 14 15 What is the next thing that happened Q after you got that? 16 The letter was translated by Sergeant 17 Α 18 Oller. Would you like me to read into the record what 19 it says? 20 I already provided a copy and MR. TUNKEY: 21 one is in the Court file, and there is only one such 22 letter and envelope. 23 For the record, I don't MR. JOSEFSBERG: 24 think I received a translated copy, but I was previously

1	shown one.
2	Just sent me a translated copy.
3	MR. TUNKEY: Yes.
4	MR. JOSEFSBERG: But I have previously been
5	shown it.
6	MR. TUNKEY: It is also I might add part of
7	the record at the preliminary hearing, and you do have
8	a transcript of that I would assume.
9	If you recall it was read into the
10	record at the preliminary hearing by a different
11	interpreter.
12	Q (By Mr. Josefsberg) What happened then?
13	A According to the letter, Mr. Canto
14	would be contacted by telephone advising him where to
15	bring the \$800, also advising him if he did not bring
16	the \$800 that they were going to dynamite his house
17	and his car and they were going to fill him full of
18	lead, kill him.
19	We received permission from Mr. Canto
20	to monitor telephone calls at his house.
21	We gave Mr. Canto an electronic record-
22	ing device with a device where he could monitor phone
23	calls and instructed him on how to use it and advised
24	him to take the tape recorder home in the event that

1	he received a call prior to the 15th.
2	After that time myself and Sergeant
3	Oller discussed the feasibility of having Mr. Canto
4	receive a call at his house, and we decided it would
5	be better if we placed the call to Mr. Donestevez and
6	we monitored the call ourselves; that way it would
7	eliminate any problem with any monitoring the call,
8	or it would eliminate the problem of possibly a mal-
9	function.
10	We felt this would be an important part
11	of this case.
12	So on the 14th of February 1972 at
13	9:30 a.m., in my office we made a tape recorded con-
14	versation where Mr. Canto called Mr. Donestevez at his
1 5	boat factory.
16	Q You furnished me with a translation of
17	that conversation, right?
18	MR. TUNKEY: Right, and also a copy of the
19	tape recording.
20	Q (By Mr. Josefsberg) Let's backtrack and
21	get the dates straight.
22	When did Mr. Canto bring you the letter
23	and envelope?
24	A The 12th of September.

1	Q On the first day he came into see you?
2	A No, sir.
3	The 12th of September he brought the
4	letter back.
5	MR. TUNKEY: Are you saying he saw you twice
6	that day?
7	THE WITNESS: No, sir; he saw us twice, once
8	when he came in and made the original report to us and
9	we made the original investigative report.
10	He made the original allegations then.
11	The next time he returned was when he returned with a
12	letter.
13	Q (By Mr. Josefsberg) When was that?
14	A That was on the 12th.
15	Q When was the first day he came in?
16	Because you already testified the first time he ever
17	came was Tuesday, September 12th at 1 p.m.
18	A You're correct and I am in error.
19	He returned at 1 p.m. He then came
20	back that afternoon and advised that when he had re-

Did you give him a receipt for the 1 Q 2 letter? 3 Yes, sir. Α 4 Q Could you look at that receipt and see 5 the date on it? 6 Yes, sir. Α 7 (After examining documents.) It is 8 apparently still the one that is in the lab report. 9 I gave him a receipt that date but I don't have a 10 copy of the receipt. 11 I gave him a receipt the date I received the letter and I submitted the letter from myself up 12 13 to the Crime Lab for latent analysis. 14 I apparently gave them the entire copy 15 of the property receipt and have not received from them 16 my copy. 17 Q, Have you written a memo indicating that 18 he returned on September 12th which refreshes your 19 recollection and makes you sure that he came in a 20 second time on September 12th, or is that just a matter 21 of your memory? 22 A I am almost certain that he returned that 23 afternoon. 24 If he didn't return that afternoon it

was the next morning. 1 Sergeant Oller talked to him. I can't 2 speak Spanish. 3 Every time that we ever talked to him 4 I had to have a translater there. I would be able to 5 advise you as to the exact date as soon as I get my 6 copy of the property receipt on the letter. 7 Q, And the next time you saw him was on 8 the 14th when he came in at your request--9 А Yes, sir. 10 Q. --because you and Sergeant Oller weren't 11 completely happy with him doing taping at his home, you 12 would prefer it where you could control the situation? 13 Α Yes, sir. 14 Q On the 14th he came in at your request, 15 not in order to turn in a letter or an envelope? 16 No, sir, not to my knowledge. Α 17 I could be in error. 18 I wouldn't know until I get a copy of 19 the property receipt, which I don't have here. 20 But I do know when he came in that 21 22 Sergeant Oller and I had discussed the probability of 23 him making the call from his home, and we decided that 24 wasn't the best way to do it, and that we would control

1 the telephone conversation, which we did at 9:35 a.m. 2 9:25 a.m. 3 Q What happened after that phone call of 4 September 14th? 5 A Mr. Canto was instructed on the tele-6 phone to bring the money, after advising Mr. Donestevez 7 that he had the money. 8 MR. TUNKEY: I object. I don't think you 9 are being responsive to the question. 10 Q, (By Mr. Josefsberg) What you are doing 11 is, by way of background you are saying that in the 12 conversation Donestevez and Canto made certain arrange-13 ments? 14 Α That's correct. 15 And therefore "We did the following"? Q. 16 Α That's correct. 17 Q We know what is in the transcript. 18 Α Yes, sir. 19 So why don't you just say "Based upon Q 20 the transcribed conversation we did the following"? 21 Α Exactly as Mr. Josefsberg just said, we 22 did the following: 23 We had Mr. Canto come to Mr. William 24 Tunkey, Assistant State Attorney's office, where a

sworn deposition was taken. 1 Sergeant Oller translated, Mr. Tunkey 2 asked the questions. 3 4 And based on that information we prepared warrants, robbery warrants, for Mr. Ramon Donesteve: 5 Mr. Emelio Navarro and Mr. Alfredo Ruiz. 6 7 Q. Were those filed and were arrest warrants issued? 8 Yes, sir. Α 9 Q On September 14th? 10 Yes, sir. Α 11 Q Who was given the responsibility of 12 executing those warrants? 13 They were directed to my attention. А 14 Q You received them on September 14th? 15 Α Yes, sir. 16 After receiving those warrants--strike 17 Q that. 18 19 In the preliminary conversation of 20 September 12th was any exact amount of money mentioned by Mr. Canto, as to how much he was instructed to re-21 22 turn with? 23 THE WITNESS: Repeat the question (addressing 24 the Reporter).

1	(The pending question was
2	thereupon read by the Re-
3	porter as above recorded.)
4	THE WITNESS: He was advised that he had to
5	pay \$800 on the phone call of the 14th when he called;
6	he said, "I have the money."
7	Q (By Mr. Josefsberg) But on September
8	12th he came in and told you about an event that had
9	transpired on September 1st?
10	A Yes, sir.
11	Q I would like you to look at your notes
12	of that date and see if anywhere in there you have the
13	figure \$800.
14	A I believe there is.
15	(After examining documents.) Yes,
16	Canto advised us that Navarro stated to himthis is
17	in quotes "You will have to leave with us something
18	you possess in order to guarantee you will bring us
19	the \$800."
20	Q Getting ahead to September 14th, after
21	you received the arrest warrants against three gentle-
22	men, the three subjects for robbery, what happened
23	next?
24	A Originally the transaction was to take

place at 6 o'clock p.m. 1 On what day? Q. 2 This was on the 15th of September. Α This 3 4 would be the date of the payoff. At approximately 7:30 in the morning--5 Let's backtrack a minute. Q 6 Did you do anything about getting a 7 search warrant? 8 Yes, sir. Α 9 Q Tell me what you did. 10 Based on the phone call which was made A 11 on the 14th, whereas Mr. Canto was advised by Mr. 12 Donestevez that if he paid him \$800, that he had his 13 personal assurance, "he," Donestevez' personal assurance 14 that he would return to him his jewelry, he said he 15 would have it there for him, and they made arrangements 16 to meet at Mr. Donestevez' boat factory. 17 Based on this updated probable cause, 18 19 I contacted Mr. Tunkey and procured a search warrant 20 for the business. What do you mean "updated"? 21 Q When you 22 first saw him, Mr. Tunkey, you already had that infor-23 mation. 24 The phone call was made on the 14th. Α

1 That would be the updated information. 2 The original robbery took place on the 3 I had no reasonable ground to believe that the lst. 4 stolen property would still be in the same location 5 from the 1st to the 14th of September. 6 On the 14th of September I had reason-7 able ground to believe that the property would be 8 there. 9 You had reasonable grounds to believe Q. 10 it was there, or that you could cause it to be there? No. I had reasonable grounds to believe 11 Α it would be there. 12 13 Mr. Canto--14 Q.
