SUBJECT: Transmitting CTC Financial Statement

The Cuban Confederation of Labor, apparently in another financial crisis, announces that it is making plans to effect economies to meet a \$13,000 monthly deficit in its treasury. These economies would be in addition to recent cuts in personnel and salary decreases resulting from the failure of the BATISTA Government to continue monthly subsidy payments (acknowledged in CTC financial statement) which had been the practice of the former regime.

The Secretary-General, Eusebio MUJAL, said that the present crisis was due to the failure of union members to pay their proper dues in the CTC. In this connection, the enclosed statement of finances was published by CTC in practically all the Habana newspapers.

COMMENT

An interesting point in the CTC's financial statement is the debt to Mujal listed at \$118,000 which a footnote says he has now canceled. This would seem to be an unusually large sum of money for a labor leader to be in a position to lend. Apropos of this, Alerta commented: "The Secretary-General of the CTC has made a present of \$118,000 to that organization. Obviously it is not an insignificant amount of money for any laborer; furthermore we do not believe that in the history of labor there exists a leader who has so clearly proven his generosity and sacrifice".
