SUBJECT: National Assembly of the Liberal Farty Elects Its Executive Committee and Proclaims Candidacy of Suarez Rivas for Vice President

The National Assembly of the Partido Liberal (PL) meeting on January 13 elected Dr. Eduardo SUAREZ Rivas as President of its Executive Board for the third consecutive time. It also passed a resolution calling for the fulfillment of the Liberal pact with the PRC(A). In this latter connection the Assembly expressed the opinion that this included the nomination on the Government coalition ticket of a PL member for the vice presidency. Suárez Aivas was named as the party's candidate for this position.

In the principal speech of the Assembly Dr. Suárez Rivas praised the pact which the PL had entered into with the Government and called for a round of applause for President PRIO. Suárez Rivas referred to the attacks of the Government opposition and the "attempts of our enemies to cause the disappearance of the Liberal party". He said, however, that instead of disappearing the party now has more than 200,000 affiliates throughout the Republic.

There is attached a list of the new Executive Board of the Liberal Party.

Comment

The Liberals are basing their demand for the vice presidency on their pact with the Government. They undoubtedly feel that the 208,000 affiliates which they obtained in the recent registration period now give them a chance to press their point. Nevertheless the Democrata party with a larger affiliation 1/ is also claiming the right to the vice presidential nomination for minister of Health ANDREU. The probable entrance of CASTELLANOS! INC into the Government coalition may further complicate the problem. ALONGO Fujol of the FNC and Ramón ZAYDIN of the FL nave been making attacks against each

other's party publicly in recent days, making it appear likely that the PNC would object strongly to the candidacy of Suárez Rivas. Also, many PRC(A) leaders think that an Auténtico like CASERO or LANCIS should be the vice presidential candidate. (The choice of an Auténtico might well be a solution to avoid favoring any one of the other coalition parties.) In any event, in view of the number of aspirants for the position it is far too early to predict who will be the final choice as HEVIA's running mate. The fact that the nomination is now suddenly sought after is an indication of the greatly improved status of the government coalition relative to the June elections.
