Composition of the Consultative Coungil Announced

The membership of the Consultative Council was announced after the meeting of the Council of Ministers on Friday, April The President of the Council is Dr. Carlos SALADRIGAS y Zayas, prominent and respected politician of the PAU and BATISTA candidate for the presidency, defeated by GRAU in the 1944 election. The Vice President of the Council is Dr. Jorge GARCIA Montes, a prominent PAU leader (Representative from Las Villas). The two Secretaries of the Council are Dr. José Elias OLIVELLA, a PAU member, physician and sugar planter; and Dr. Walfredo RODRIGUEZ Rodriguez, Director of the Camaguey newspaper El Camagueyano and PAU Representative from Camaguey. The President and Vice President of the Consultative Council are to have seats on the Council of Ministers. There are 78 members, including officers of the Council.

The functions and other attributes of the Consultative Council are contained in Articles 135 through 144 of Batista's "Constitutional Law". Article 135 specifies that the number of members will be decided by the Council of Ministers, and (N Article 136 says that the members will be selected by the President from "outstanding representatives of tife fundamental activities of the nation". Requirements for membership are stated in Article 137 to be only those of Cuban nationality, over 21 1 N years of age, and to be in "full enjoyment of civil and political-OI rights". N

The Consultative Council must be heard, according to Article 138, in the following cases:

- a) Commercial treaties with other countries.
- b) Establishment of taxes on a national level.
- c) Budgets of expenses and income of the State.

d) National loans.

- e) Regulation of systems of weights and measures.
- f) Declarations of war and treaties of peace. g) Laws affecting production or labor.

The Council may initiate laws, which will be submitted to the Council of Ministers in detailed form, and it will undertake studies for the revision of laws, according to Article 139. Article 140 provides that a majority of those present is necessary to approve a report, and that a quorum consists of half the total members of the Council.

Article 141 provides for a President, Vice President and two Secretaries, to be designated by the Council of Ministers. Article 142 provides for per diem in the amount decided by the Council of Ministers (\$30 per session, up to a limit of \$600 per month). Article 143 grants immunity to members "for opinions and votes they may emit in the exercise of their functions".

One of the first tasks of the Council presumably will be to draw up its own rules. This is required in Article 144 of the Constitutional Law, which provides that this "Internal Regulation" be submitted to the Council of Ministers within two weeks from the time the Council is constituted.

The meeting place for the Council has not been decided. One group reportedly favors the <u>Capitolio</u> and another apparently would like to stay out of it to avoid the substitution of Congress implied in use of the <u>Capitolio</u>. General Batista's views, which will be the deciding factor, are not yet known.

The first reaction to the announcement was that of the Ortodoxo Party, which expelled the three members of the Party who had accepted seats on the Council because of the "spurious and usurping nature" of the Council and for swearing to uphold the "Constitutional Statutes" declared null and invalid by the Party. The three members were: Ramon VASCONCELOS, Lelio ALVAREZ Ramirez, and Conrado RODRIGUEZ.

The first editorial reaction was that of El Mundo which praised the abilities of the President and Vice President but found the composition of the Council mediocre. It said, "This Council will do no more to inspire faith in the people than the one thrown out of the Capitolio". It found that the members designated, for the most part, do not fulfill the hopes of public opinion which "feels defrauded". This opinion was echoed by Mañana, which found the Council to be of "inferior category...with little-known names and some too well-known names".

The only other newspaper to comment on the Council so far has been the Communist Hoy, which called it "even smaller and less capable than it had thought possible". It said the

Council members "represent and serve him who appointed them first and then the classes to which he and they belong: the exploiting classes who are ruled by foreign imperialism". It concluded, saying that the announcement of the composition of the Council should stimulate the opposition of the masses, rather than diminish it.
