SUBJECT: Consultative Council Holds First Substantive Meeting, Appoints Committees.

The Consultative Council held its first meeting May 22 under its Rules, approved by the Council of Ministers on May 14. The meeting was devoted largely to consideration of the composition of the standing committees of the Council. After the Council approved the committee membership designations (see enclosed list), the committees were convoked for meetings May 26 and 27 in the Council's new office space in the former Soviet Legation building.

José María VAZQUEZ Prieto, who had been designated to fill the vacancy left by the resignation of Conrado RODRIGUEZ, was sworn in at the meeting, to bring the Council membership to the full 80 members.

The Council of Ministers submitted the following matters for study to the Council, which were referred to committees: Organic Law of Labor Tribunals, to the Justice and Codes and Social Matters Committees; Juvenile Courts, to Justice and Codes; and Regulation of Vegetable (Frutos Menores) Cultivation, to the Agricultural and Livestock Production Committee. Propositions submitted by Council Members were also sent to committees, as follows: application of the summer work-day schedule, initiated by Carlos M. RAGGI, to the Social Matters Committee; creation of a Committee to Investigate Communist Activities, initiated by Luis ORTEGA, to the Justice and Codes Committee.
