- 11. Yes. I met Carlos Alvarez in 1962 at Catholic church gatherings in Miami at the age of 15 and was socially acquainted to him until my marriage in 1965. I did not see him again until 1997 at a board meeting of the Cuban Committee for Democracy where I served as Executive Director and the President of such, Dr. Alejandro Portes of Princeton University, had invited him as a guest

to one of our board meetings. He eventually became a board member of the CCD and I saw him sporadically in that role.

Dr. Alvarez was hired by Puentes Cubanos, Inc., in 1999 to serve as facilitator of one of our Cuba programs, dealing with conflict resolution and Cuban identity between young Cuban American professionals and their counterparts in Cuba. He traveled to the island for Puentes Cubanos multiple times as facilitator of such. Each trip lasted approximately one week. He also participated in a conflict resolution workshop at FIU North Campus and at Harvard University Kennedy School of Government.

12. The following is the information provided to the board of Puentes Cubanos by Dr. Alvarez.

Clinical Psychologist who was an Associate Professor of International and Inter Cultural Development Education at FIU and Associate Member of the Program on International Conflict Analysis and Resolution at Harvard Univ. He also maintained a part-time private practice in clinical psychology in Miami.
