ISSUED, *January 5th* 18*89*

I, *Louis Schlesinger*, a naturalized and loyal citizen of the United States, do hereby apply to the Legation of the United States at *Paris* for a passport for ~~myself and wife, and my minor children~~ as follows: *Alfred Schlesinger* born at *San Miguel (Salvador)* on the *22* day of *July*, 18*72*, and

In support of the above application, I do solemnly swear that I was born at *Nykarina Kuopio*, on or about the *9* day of *March*, 18*25*; that I emigrated to the United States, sailing on board the *Europe*, from *Liverpool*, the day of *December*, 18*49*, and arriving at *New York* the day of *December* 18*49*; that I resided five years uninterruptedly in the United States, from *1849* to *1857* at *New York*; that I was naturalized as a citizen of the United States before the *Supreme* Court of *Commonwealth*, at *New York*, on the day of *1856*, as shown by the accompanying certificate of naturalization; that I am the bearer of Passport No. *242*, issued by *Gov. R. M. W. Sew* *Paris* on the *24* day of *June*, 18*88*, which is returned herewith; that I am the identical person referred to in said certificate and passport; that I am domiciled in the United States, my permanent residence therein being at *New York*, in the State of *New York*, where I follow the occupation of *gentleman*; that I last left the United States on the day of *May*, 18*87*, on board the *Britannia*, arriving in *Havre* the day of *May*, 18*87*; that I have resided in *Paris* since the day of *1882*; that I am now temporarily residing at *29 Rue de Valenciennes*; and that I intend to return to the United States *within August* with a purpose of residing and performing the duties of citizenship there.

I desire the passport for the purpose of *studying my son back to Germany for educational purposes, which he cannot return without a passport*

Further, I do solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I take this obligation freely, without any mental reservation or purpose of evasion: SO HELP ME GOD.
