
The Plaintiff, MARION BEZNER, sues the Defendants,  
EMILIO MILIAN and LAZARO MILIAN, and alleges:

1. That the parties are residents of Dade County, Florida.
2. That on or about June 3, 1967, the Plaintiff, MARION BEZNER, occupied and operated her automobile in an easterly direction upon Northwest 7th Street near Northwest 12th Avenue in Miami, Dade County, Florida.
3. That at said time and place, the Defendants, or either of them, owned and/or maintained a motor vehicle then operated by the Defendant, EMILIO MILIAN, in a southerly direction on said Northwest 12th Avenue in such a negligent and careless manner so as to directly and proximately cause it to violently collide with Plaintiff's automobile, thereby causing the Plaintiff to sustain the damages and injuries hereinafter alleged.
4. That as a direct and proximate result of the Defendants' negligence and carelessness, the Plaintiff, MARION BEZNER, sustained diverse injuries to and about her head, body, spine and nervous system, the nature and extent of said injuries being either permanent or continuing and requiring hospital and medical care, attention and expense; that the Plaintiff has suffered and will in the future suffer intense and continued

pain and discomfort of both mind and body and has permanent disfiguring facial scars; that she has in the past and will in the future be prevented from leading a normal life, and has suffered and will suffer the loss of time in her employment; Plaintiff has suffered the loss of her motor vehicle and will suffer other losses as a direct result of Defendants' negligence.

WHEREFORE, by reason of the foregoing, Plaintiff seeks damages against the Defendants, EMILIO MILIAN and LAZARO MILIAN, in a sum exceeding \$5,000.00, exclusive of costs and interest, and demands trial by Jury.
