THE COURT: Ready with the matter of Luis A. Crespo?

MR. WOODARD: State's ready.

THE COURT: And on behalf of the defendant?

MR. GREENSPAHN: Defendant is ready. Melvýn Greenspahn for the defendant.

THE COURT: All right.

Before we proceed further, I think the record should reflect that the Court originally, pursuant to the jury verdict finding both defendants Crespo and Lopez guilty, set sentencing for October 21st of this month, and allowed the Florida Probation and Parole Commission until that time to prepare its report.

When it became necessary to revoke or to raise the bond of the defendant, Crespo, the Court then entertained and granted a request by the defense to accelerate the sentencing date.

The matter was on for report Monday and at my request, Florida Porbation and Parole Commission accelerated and with -- they were able to have the report ready. And it was, in fact, ready for Monday; that this matter was then postponed until this morning at the request of defense counsel, is that correct, counsel?

MR. GREENSPAHN: That's a correct statement.

THE COURT: So that you might prepare for the sentencing hearing. But that the record should reflect that the Probation and Parole Commission was ready Monday with its report and in oral form.
