80 Your valued favor of July 7<sup>th</sup> covering a communication from the Spanish Minister at Washington saying "the fine imposed on the "Queen of the South" would be refunded, provided the Captain had not been in Cuba since Dec 19<sup>th</sup> 68 to the time the fine was imposed" was duly received.

I immediately forwarded the necessary papers to Hon. C. H. Bithorn at Manzanillo, proving the above fact, and as I received no answer have again written him.

I have learned from one of my Captains who arrived from Manzanillo last week that Mr. Bithorn is awaiting a communication

from the Authorities at Havana to  
the Custom House, authorizing them  
to refund the amount, and shewken  
you would write the Consul General  
at Havana. I have taken the liberty

Sir

Referring to your letter of the 7th  
July addressed to my predecessor, in  
relation to the Steamer Upton and  
her alleged violation of the neutrality  
laws I beg leave to say that the vessel  
is still lying in this harbor with  
no apparent movement indicating  
an intention to depart.

An examination of the deposition  
and other documents furnished to this office  
by counsel for the Spanish authorities  
shows quite satisfactorily the breach  
of the neutrality laws by the Upton  
and I think the facts shown by the  
deposition, if properly proved to the  
Court would cause a condemnation.

I have thought that under present  
circumstances, it might be better to  
refrain from instituting proceedings  
against the Winton until she shows  
some signs of preparation for a  
new voyage. She is thoroughly  
watched and on the first indication  
of a design to renew her violation  
of the neutrality law, she can be  
promptly libelled for her past offenses.

If you think best however that the  
proceedings be commenced without delay  
advise me & I will act accordingly.

Sir.

The undersigned, a native of Cuba,  
and a Citizen of the United States, and for the  
last year, a resident of this city, begs leave  
to call the attention of your Excellency, to the  
following facts, which caused him to leave the  
island of Cuba, with all of his interests therein,  
and seek in the United States, with his family,  
that peace and security, which from the civil war  
existing in Cuba, he was fearful might not be  
accorded him. On the 2<sup>d</sup> of April 1869,  
with my family on board the Steamer Liberty,  
I left Havana, for New Orleans, and after a resi-  
dence of five months in that city, I left for this  
place, as having a climate more like the one, I  
was accustomed to, and offering facilities of  
hearing at least every few days from my home.

My age is 52 years, nor have I in  
the least, taken any part in the civil commotion  
disturbing Cuba, by any action open or covert;  
and have most studiously kept aloof from the  
associations of politicians, whose design was  
revolution.

I have not been in New York, since I  
left Havana, nor am I a member of the Cuban  
Junta thereat, in any way, direct or otherwise.

And yet, by reason of some one of its  
members, bearing a name somewhat similar to  
mine, the Spanish Government, have identified me,

as the party of New York, and ordered my property for confiscation in Havana. I trust that so bold and outrageous a wrong, you Excellency will not permit, - and at once stay by your authority, the consummation of an act, which has not a shadow to justify it.

My property in Havana, consists of 32 houses, and a small farm at Cieno, yielding a monthly rent of \$1558. In my private residence, I had rich and valuable furniture, carriages, jewellery, etc., valued at \$10,000.

The property of my wife's family, consisting of a Sugar plantation, whose annual income was from 130. to 150 thousand dollars, was under my Superintendance, and yielded me a percentage from 8. to 9 thousand dollars.

The aforesaid property is all abandoned, and is suffering such deterioration and injury, as to render all estimate, uncertain in the extreme.

The amount of Specie left by me in the Chest of said Sugar plantation, was between 84 to 90 thousand dollars, and said amount is in great danger of being removed, if not immediately ordered to be restored to me.

With this relation of my property and interests in Cuba, thus jeopardized injured and sequestered by the Spanish Authorities, I appeal to your Excellency as an American Citizen, simply asking but Justice, and that your Excellency will give the subject that consideration and action, that its importance demands.

Leaving the troubles which were around me in Cuba, I sought this land of my adoption and Citizenship, in the hope that peace and quiet

might be accorded me, and that at least, the Revenues  
of my property there, might keep my old age, from the  
harassing privations of want.

In this I am disappointed, - And I now ask  
you Excellency's intervention in my behalf as an  
American Citizen, - that this property be at once  
restored to me, with compensation for its unjust  
detention and injuries, by the Spanish Government,  
amounting to this day (20<sup>th</sup> August) Fifty thousand  
dollars.

All of these statements are true, and sus-  
ceptible of the best testimony: and in conclusion, the  
undersigned hopes, that this appeal, from an American  
Citizen to his Government if the wrongs inflicted on  
him, by Spanish Authority, will be promptly investi-  
gated, and redressed.
