## Bomba Significa "Guerra Contra El Camarada Fidel"

El primer Ministro de Guyana, Forbes Burnham, dijo que el atentado contra un avión de pasajeros de la empresa Cubana de Aviación, es "una declaración de guerra contra nosotros en Guyana y contra nuestros camaradas en Cuba".

La versión de su discurso fue distribuida en Nueva York por una firma de relaciones públicas.

Burnham indicó que en el avión en cuestión había dos personas "José Vásquez, ese es uno de sus alias, y Freddie Lugo, quienes dicen tener pasaportes venezolanos".

Los dos dejaron el avión antes de que iniciara su último vuelo desde Barbados y poco después del despegue el aparato cayó al mar. Burnham dice que la tragedia se debió a una explosión y que el aparato se precipitó a una milla y media de la costa. Indicó que entre los viajeros había 11 de Guyana.

También sostuvo que Vásquez, es cubano naturalizado venezolano y que Lugo parece ser oriundo de Colombia y también nacionalizado como venezolano.

# FBI Rumored Taking Letelier Probe Abroad

The Institute for Policy Studies reported yesterday that the Federal Bureau of Investigation is sending agents to Venezuela as part of the FBI's investigation of the bombing death here of former Chilean Ambassador Orlando Letelier.

Venezuelan police recently arrested a group of right-wing, anti-Castro Cubans, including Cuban exile leader Orlando Bosch. Bosch, who is wanted by U.S. authorities for a parole violation stemming from a Florida bombing incident, heads an anti-Castro umbrella group known as the Coordination of United Revolutionary Organizations.

According to the Caracas newspaper *El Nacional*, Bosch has implicated two brothers—identified only as the "Novos"—in the Letelier killing.

The Institute for Policy Studies, a leftist "think tank" here, is following the Letelier investigation because Letelier had headed a foreign policy research program at the institute after his release from imprisonment by the present Chilean military junta.

Letelier, who had been ambassador to the United States, foreign minister and minister of defense in the Marxist government of the late Chilean President Salvador Allende, died Sept. 21 when a bomb exploded beneath his car as he drove through Sheridan Circle on Massachusetts Avenue's Embassy Row.

Ralph Stavins, a researcher at the Institute for Policy Studies, said he learned in a conversation with an FBI official yesterday that one or two FBI agents would go to Venezuela today. FBI officials refused to confirm the institute's statements.

Sources close to the investigation have previously said that investigators wanted to question Bosch and other right-wing Cubans about Letelier's death. The sources said that this was only one line of investigation and that the focus of the investigation has not narrowed to Bosch and right-wing Cubans.

In another development, it has become known that an FBI agent working on the Letelier investigation has apparently received a threat.

According to knowledgeable sources, the fiancee of the FBI agent was approached at a New York airport by a man who warned her that the agent should get off the Letelier investigation. Otherwise, the woman was reportedly told, the FBI agent's life would be endangered.

The Institute for Policy Studies issued its statement yesterday because it wanted, Stavins said, to counter any possible impression that the present Chilean government was not involved in Letelier's killing. Chilean officials have previously denied any link with Letelier's death and condemned the bombing.

The Institute for Policy Studies said that even if the investigation focuses on Bosch's right-wing Cuban group, there still may be links with Chile. The "Novo" brothers have "worked directly with DINA, the Chilean secret police," the institute said in its statement.

## Judge Rules Cooperperson Is Officially a Cooperman

NEW YORK, Oct. 17 (AP)—A Long Island woman was denied permission today to change her name from Ellen Cooperman to Ellen Cooperperson.

In his decision, state Supreme Court Justice John Scileppi said the change would expose the women's liberation movement to ridicule. He added that there are many American surnames that might be subject to such a "ridiculous change" if he granted the petition.

Cooperman, who lives in Babylon with her 9-year-old son, said she has been using the name Cooperperson about three years and is listed in the telephone book under that name.

La revista estima que después de la publicación de la entrevista Novo "deberá sufrir la cólera de sus protectores, que no aman la publicidad".



The United States Attorney for the District of Columbia, Earl J. Silbert, respectfully moves this Court to issue an order pursuant to the provisions of Title 18, United States Code, Sections 6002-6003, compelling Alvine Ross to give testimony and provide other information, which he refuses to give and provide on the basis of his privilege against self-incrimination, as to all matters about which he may be interrogated before the Grand Jury of the United States presently empaneled within this District, and respectfully alleges as follows:

1. The witness, Alvine Ross, appeared before the Grand Jury on April 6, 1977, at which time the witness invoked his Fifth Amendment privilege and refused to answer questions relating to the Grand Jury's investigation of possible violations of 18 U.S.C. §1116 and 22 D.C.C. §2401.

2. It is the judgment of the United States Attorney for the District of Columbia that the testimony of Alvine Ross is necessary to the public interest and accordingly that this Motion should be granted compelling his testimony pursuant to a grant of immunity.

3. This Motion is made with the approval of Benjamin R. Civiletti, Assistant Attorney General, Department of Justice, pursuant to the authority conferred by 18 U.S.C. §§6002-6003 and 28 C.F.R. 0.175. A copy of the letter from said Assistant Attorney General expressing such approval is attached hereto.

Therefore, the United States respectfully moves this Honorable court to sign the attached Order compelling Alvine Ross to directly and in a non-evasive manner answer before the Grand


