AS OF 29 MARCH 1965, THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVELUCIONARIA (MIRR, INSURRECTIONAL MOVEMENT FOR REVOLUTIONARY RECOVERY), LED BY ORLANDO BOSCH AVILA, HAD COLLECTED \$22,000 IN PUERTO RICO AND PLANNED TO BOMB AN UNIDENTIFIED SUGAR REFINERY IN CUBA. AFTER THE MIRR CARRIES OUT THIS OPERATION, IT PLANS TO CALL A PRESS CONFERENCE AND ANNOUNCE THE FORMATION OF A GOVERNMENT IN ARMS WHICH WILL POSSIBLY BE REPRESENTED BY BOSCH HIMSELF. SUCH A GOVERNMENT IS TO BE RECOGNIZED BY THE DOMINICAN REPUBLIC.
