The Grand Jury charges:

COUNT ONE

That from on or about December 10, 1966, and continuously thereafter up to and including January 13, 1967, in the Southern District of Florida, the defendants,

ORLANDO BOSCH y AVILA,
LOUIS CONCEPTION BERTOT,
JOSE ANTONIO MULET y GONZALES,
also known as "GUAJIRO,"
JOSE DIAZ y MOREJON,
also known as "PIERTO," and
MARCOS RODRIGUEZ y RAMOS,

unlawfully, wilfully and knowingly did conspire with each other and with divers other persons to the Grand jury unknown, to violate the laws of the United States, to-wit: Title 18, United States Code, Section 1659, in the manner and by the means hereinafter set forth.

1. It was the plan of said conspiracy to violate Title 18,
United States Code, Section 1659, by knowingly, wilfully and unlawfully
conspiring to by open force maliciously attack vessels belonging to citizens
of foreign countries including among others, ships of Spain, Canada and

It was further a part of the said conspiracy that the said defendants and co-conspirators would procure aerial-type bombs and other explosive materials and the use of an airplane in the United States.

It was further a part of the said conspiracy that the said defendants and co-conspirators would cause bombs to be transported from the United States to an area east of Florida on the high seas in an airplane for the purpose of dropping and exploding the bombs on the aforementioned foreign ships.
- 4. It was further a part of the said conspiracy that the said defendants and co-conspirators would cause sand bags to be dropped from an airplane over an area in the Southern District of Florida as a means of training for dropping bombs from an airplane.

In pursuance and furtherance of the said conspiracy and to effect the objects thereof, the defendants and their co-conspirators did commit in the Southern District of Florida, the following overt acts, among others:

OVERT ACTS

- 1. On or about December 10, 1966, Orlando Bosch y Avila,

 Jose Antonio Mulet y Gonzales, also known as "Guajiro," Jose Diaz y

 Morejon, also known as "Pierto," and Louis Conception Bertot, defendants

 herein, did meet and have a conversation with Arthur Andrew Girteit in

 Miami, Florida, in the Southern District of Florida.
- 2. On or about December 31, 1966, Orlando Bosch y Avila, a defendant herein, exhibited to one Arthur Andrew Girteit three aerial bombs in Miami, Florida, within the Southern District of Florida.

3. On or about January 5, 1967, Jose Diaz y Morejon, also known as "Pierto," and Marcos Rodriguez y Ramos, also known as "Mongos," defendants herein, traveled from Miami, Florida, to a place near the Tamiami Trail in the Everglades in Dade County, Florida, within the Southern District of Florida.

4. On or about January 9, 1967, Marcos Rodriguez y Ramos, also known as "Mongos," a defendant herein, traveled from Miami, Florida, to Opa Locka Airport in Dade County, within the Southern District of Florida.

5. On or about January 10, 1967, Orlando Bosch y Avila,

Jose Antonio Mulet y Gonzales, also known as "Guajiro," traveled from

the El Nido Motel to 237 S. W. 22nd Avenue in Miami, Florida, within

the Southern District of Florida.

All in violation of Title 18, United States Code, Section 371.

That from on or about December 6, 1966, to December 10, 1966, and thereafter from January 13 to January 15, 1967, in the Southern District of Florida, the defendants,

unlawfully, wilfully and knowingly did conspire with each other and with other persons to the Grand Jury unknown, to violate the laws of the United States, to-wit: Title 22, United States Code, Section 1934, and the rules and regulations duly promulgated thereunder (22 C.F.R. 121.01 et seq.) in the manner and by the means hereinafter set forth.

1. It was the plan of the said conspiracy to violate Title 22, United States Code, Section 1934, and the rules and regulations duly promulgated thereunder, to-wit: 22 C.F.R. 123.01, 123.02, 123.09 and 126.01 by knowingly, wilfully and unlawfully exporting from the United States to places outside the United States ammunition and implements of war as designated by Categories I, III, IV and V and VIII of the United States Munitions List (22 C.F.R. 121.01), without having obtained therefor an export license or the written approval from the United States Department of State.

2. It was further a part of the said conspiracy that the said defendants and co-conspirators would cause bombs and other explosive materials to be transported from the United States to Cuba in an airplane for the purpose of dropping and exploding the bombs and other explosive materials on a designated area in Cuba.

In pursuance and furtherance of the said conspiracy and to effect the objects thereof, the defendants and their co-conspirators did commit in the Southern District of Florida, the following overt acts, among others:

OVERT ACTS

- On or about December 6, 1966, Orlando Bosch y Avila and Jose Antonio Mulet y Gonzales, also known as "Guajiro," defendants herein, did meet and have a conversation with Arthur Andrew Girteit in Miami, Florida, in the Southern District of Florida.
- 2. On or about January 14, 1967, Orlando Bosch y Avila and Jose Diaz y Morejon, also known as "Pierto," did meet and have conversation with Arthur Andrew Girteit at 237 S. W. 22nd Avenue in Miami, Florida, in the Southern District of Florida.

3. On or about January 15, 1967, Marcos Rodriguez y Ramos, also known as "Mongos," Jose Diaz y Morejon, also known as "Pierto," and Barbaro Balan y Garcia, defendants herein, traveled from the vicinity of 3149 S. W. Eighth Street, Miami, Florida, to the Tamiami Airport, Miami, Florida, within the Southern District of Florida.

All in violation of Title 18, United States Code, Section 371.
