ACTING MINISTER OF STATE, ARMANDO HART YESTERDAY SENT NOTE TO DOMINICAN CHARGE VIA PAPAL NUNCIO SUSPENDING DIPLOMATIC RELATIONS WITH DOMINICAN REPUBLIC. USE OF PAPAL NUNCIO RESULTED FROM LACK CUBAN DIPLOMATIC REPRESENTATIVES CIUDAD TRUJILLO AND STATED INABILITY LOCATE DOMINICAN CHARGE OR ACCREDITED DOMINICAN DIPLOMATIC REPRESENTATIVE IN LATTERS ABSENCE.

NOTE CITES FOUR REASONS FOR BREAKING RELATIONS.

1. FAILURE RETURN AIRCRAFT TAKEN BY BATISTA ON JANUARY 1.
2. FAILURE EXTRADITE CUBAN WAR CRIMINALS
3. "PREMEDITATED INACTION" OF LOCAL AUTHORITIES WHEN CUBAN DIPLOMATS AND EMBASSY PREMISES ATTACKED IN CIUDAD TRUJILLO.
4. RECENT VIOLATIONS OF FUNDAMENTAL HUMAN RIGHTS IN "MASS EXTERMINATION" OF WAR PRISONERS AND INDISCRIMINATE BOMBING OF DEFENSELESS CITIES".

NOTE STATES THAT GOC CONTINUED RELATIONS IN FACE OF FIRST THREE REASONS DESPITE THEIR GRAVITY IN INTEREST PRESERVE PRINCIPLE OF MAINTAINING DIPLOMATIC RELATIONS AMONG ALL GOVERNMENTS OF HEMISPHERE BUT GOC ON TO SAY THAT GOC COULD NOT "CONTEMPLATE IMPASSIVELY" ACTIONS CITED IN FOURTH REASON.

NOTE SETS NO SPECIFIC TIME LIMIT FOR DOMINICAN OFFICIALS TO LEAVE.
