SUBJECT: Cancellation of Pilots' Licenses of Cuban Aviators

On April 10, 1958, the Cuban Civil Aeronautics Commission ordered the cancellation of the Cuban Civil Aviation Pilot Licenses of fifteen Cuban pilots for violation of the rules of air navigation and air traffic. The names of these pilots are as follows:
