In a public statement on March 12, Prime Minister Fidel CASTRO declared he is studying the possibility of merging all Cuban airlines into one enterprise. Has requested a committee to report to Dr. DDTI, Minister of Economy, on feasibility. Also stated his opinion that helicopter service is answer to problem of providing air transport to all parts of island. He said bilateral air agreements are presently under study and that Gsa. Cubana de Aviación in near future wished to extend routes to Chicago and Los Angeles, etc.

Cubana de Aviación, Aerovías "Q", Cuba Aeropostal, and Expresso Aéreo definitely placed under control of National Transport Corporation thus ending intervention status under Ministry for Recovery of Misappropriated Property. Stockholders meeting of Cia. Cubana de Aviación scheduled for May 25 postponed for lack of quorum, but further changes in management of companies is anticipated.
