SUBJECT: DISTURBANCE COMPLAINT BY FATHER HUGH J. HAYES, VISITATION RECTORY, 19100 N. Miami Are.

The complainant reported that he had been assisting a parishioner named Alfred Landry, of 545 N.W. 149 Street. Father Hayes had reported that he had been supplying Landry's family with food, rent etc.

Recently Landry has become abusive and created a disturbance using profane and obscene language on the lawn of the Rectory. Since this is Sgt. McKee's Parish, he was called by Father Hayes at his home, on July 23, 1958. Sgt. McKee requested Father Hayes to call the office in the event that the subject returned.

At 10:25 A.M. July 24, 1958 Landry returned to the Rectory and was again loud, abusive and obscene. Henderson, in the complaint room was requested to send a uniformed car to the scene with instructions on how to handle the case. County car 615, Deputies Sampson and Delaney answered the call. The sujbect, Alfred Landry was booked for public drunk charges at Opa Locka Police Department. A copy of the report is attached.

A check through the Records Bureau revealed that the subject has a three page F.B.I. Record. His F.B.I. number is 1275934. A copy of his record is attached as part of this report. This case closed by arrest. Father Hayes was contacted by telephone and advised in the event of any more difficulty not to hesitate to call the Department.
