#### HISTORICAL SKETCH

The Captain Callender Irvino Fayssoux Collection of William Walker papers was acquired by the Department of Middle American Research, Tulane University from Captain Fayssour's daughter-in-law, Mrs. William Mch. Fayssoux, in October, 1933. The papers chiefly pertain to the Walker invasions of Nicaragua, 1855, 1857, 1860 and the Walker regime in that country, 1856-57. but biographical and miscellaneous data on both Fayssoux and Walker dates from 1834-1933. Fayssoux served Walker as aide-de-camp, paymaster, purchasing agent, naval commander and as minister general of the Ropublic of Nicaragua. The papers also disclose Fayssoux's connection with the Texas Navy, the Lopez expedition and the forces of the Confederacy. His foresight preserved these documents to the benefit of the historian.

The collection is contained in two metal lock boxes 15 x 7½ x 11 inches, which are deposited in the Rare Book Vault of the library of the Department of Middle American Research. In the following analysis, dates are given when possible, number of items or pages, only when in excess of one, and parentheses contain information supplied by the editors. Unless otherwise stipulated, the entry is written in English.
