

KANSAS NEWS.

The Traveller has a letter from Kansas dated Sept. 30th, from which we take the following:

"Editor of the Traveller:—We are having a short period of peace, but the Missouri Militia will probably be on hand on Monday next, the day for the bogus election. Any number of rumors are flying about, but I do not rely on them. Hard times, however, are here in earnest. Imagine paying \$3 for board, having no milk or butter, and only semi-occasionally meat. Our boys have lived days together on green corn, cabbages and squash. I have a piece of the bread, eaten in Lawrence during the last two weeks, black as a coal, and almost as hard as a brick. Nobody doubts or despairs, but every one holds on to the cause, and feels confident in the result. A great many are leaving from the Southern part of the Territory, seeing nothing but starvation before them. We trust that our friends are alive to the necessity of keeping all in that are in the Territory.

The prisoners confined at Lecompton are receiving their preliminary examination, on a charge of murder at Hickory Point, before Judge Cato, of the U. S. Court. Messrs. M. Parrott and H. Miles More of Leavenworth City, are acting as counsel for them, and the vigorous and impressive manner in which they resist the farcical and unjust ruling of the Judge, who is a smaller counterpart of Jeffries Lecompte, entitles them to the gratitude of our citizens. This trial is a perfect farce, and cannot but end in smoke. To the prisoners themselves, most of whom have families dependent upon them, and crops that want housing, this detention from their ordinary avocations is no joke, and the treatment they have received has made many of them sick. I subjoin their names, and their original residences in the States.
