faraway from my country, my soil, I claimed:


I have lost all

# Is Denied License

"La Fabulosa," Miami's "fabulous" Spanish-language radio station, WAFB-AM, the first in South Florida with Spanish broadcasting, has been denied an application to renew its license, the Federal Communications Commission announced Tuesday in Washington, D.C.

The commission authorized continued operation of the station by United Broadcasting of Florida Inc. until Dec. 17 — or, an appeal is made to federal courts, until 30 days after final disposition.

Antonio Arias, the station's news director, said Tuesday night that the decision to deny the license was expected, but that "the management has absolute confidence that the appeal will be successful." He said the appeal has been filed and that the station is not aware of any other application for the license.

IN A NEWS conference last Friday, Arias said the station's management, based in Washington, announced that it is confident of winning the appeal and that United Broadcasting is contemplating plans to expand the station's coverage to other parts of Florida. The station, on the air since 1962, entertains South Florida Latins with music, news and talk shows.

"We are confident that when we expose the service we have given to the community (in making the appeal) our license will be given back to us," Arias said.

The FCC decision affirmed a ruling in May 1974 by its administrative law judge, Byron E. Harrison, who concluded that the station had engaged in fraudulent billing practices and lacked the qualifications needed to continue as a licensed station. The judge ruled that WAFB should lose its license for permitting a local retail chain to bilk national advertisers out of more than \$50,000 in cooperative advertising money.

Judge Harrison, who held hearings in Miami, found "that neither WAFB nor United (Broadcasting) assumed responsibility for its billing practices, which permitted Crown (Trading Co., one of its major advertisers,) to engage in double billing, triple billing and fraudulent billing."

REGIONAL DISTRIBUTORS and manufacturers' representatives for products sold by Crown, said the judge, paid for advertising carried by WAFB, which Crown knew had no relation to its commercials aired by the station for a particular billing period.

Last Sept. 9, the FCC also denied the application for license renewal by WOOK-AM, Washington, D.C., licensed to United Broadcasting Co. Inc., the parent of the Florida firm. The commission ruled that WOOK had broadcast lottery information and false and misleading advertising. United Broadcasting has indicated it also will appeal that decision.

## Cab Hikes Supported

Taxicab drivers in Dade County should be allowed to raise their rates 15 per cent, Metro transportation coordinator John Dyer is recommending to the Metro Commission. If commissioners approve the hike — conceivably as soon as their meeting today — a cab ride in Dade would cost \$1.40 for the first mile and 80 cents for each additional mile, up from the current rates of \$1.20 and 70 cents. Commissioners meet at 9 a.m. today at the County Courthouse, 73 W. Flagler St.

## More Oil Poured On Water Trouble

You can't test oil samples without oil samples, so Environmental Protection Agency chemists have ordered some more from the Coast Guard. "They ran out," said Rear Admiral Austin Wagner, commander of the Coast Guard's Seventh Fleet. More oil, drawn from the holds of tankers conceivably responsible for a massive spill in the Florida Keys in mid-July, is en route to the EPA lab in Georgia. The samples are being matched against those taken from the coastline. More than 50 ships have been removed from the suspect list, which has narrowed to four.

## Wreckage Cleared From Runway

Federal investigators Tuesday finished clearing the "hardware" from a crashed cargo plane littering the east-west runway at Miami International Airport, and the runway was opened at 5:30 p.m. Specialists on the six-man National Transportation Safety Board team are studying the engines and propellers in a hangar. Arnold Holstine, investigator in charge, said the investigation has been hampered because many records on the Canadian-built Aero Transportes Entre Rios CL 44 "Yukon" in which six persons died Saturday are in Spanish, and no one on the team is bilingual. The Federal Aviation Agency is loaning the team a bilingual secretary Wednesday.

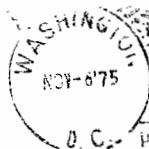
