I LOOKED UP HIS BIOGRAPHY + MADE A COPY WHICH I AM MAILING TO YOU. SENATOR MASON RETIRED IN 1975 AND KEEPS A HOUSE IN THE MIAMI AREA WHICH MAY BE THE REASON FOR HIS CONCERN WITH CUBAN PROBLEMS.
