

Research Room Rules and Procedures

Research room hours are 9:00am to 5:00pm Monday through Friday, except for national holidays. The research room may also be open by advance appointment on Saturday; please contact the Library for more information.

Researchers may make photocopies at 15 cents per page. For self-service copy instructions, please see the self-service copy handout. Reagan Library staff can photocopy material for researchers at a cost of 50 cents per page, \$10.00 minimum order. Documents that a researcher wishes to have copied by the Reagan Library staff must be tabbed, with the researcher's last name written on the top of each tab, and the documents listed on the reproduction request form.

Upon completion of a research application, showing of personal identification (such as a driver's license) and a brief orientation, the researcher will be issued a researcher identification card. This card is valid for three years, and renewable thereafter.

Researchers may not bring personal belongings into the research room. Lockers are available at no charge, but locker keys must be returned at the end of each day. Researchers may leave items overnight, but the Library does not take responsibility for their security. Upon the researcher's exit, the research room attendant may ask to inspect notes.

Researchers may not eat, drink, or smoke in the research room. Smoking is permitted outside the building only.

Only pencils, Library forms, and personal computers may be brought into the research room. The Library will supply pencils, paper, and index cards for note taking. Researchers using audiovisual materials may use pens in the Audiovisual Research Room only. Document scanners and personal copiers are not allowed.

To request material, a request slip must be filled out and returned to the research room attendant. No request slips will be accepted after 4:30pm. Researchers may request up to four cartloads at one time, but may examine only one cart of material at a time. The Library will hold material overnight if a researcher intends to continue using it the next day.

Please have only one box, and only one folder from that box, open and on the table at one time. Please mark your place in the box with a marker supplied by the research room attendant.

Handle the material with care. Please do not write on, fold, unstaple, disarrange, or otherwise handle documents in a manner likely to damage them.

ABOUT THE RESEARCH ROOM PHOTOCOPIER

- **Hours:** The self-service copier is available Monday through Friday, from 9:15am (15 minutes after the research room opens) to 4:45pm (15 minutes before the research room closes). The copier may also be made available on Saturdays, by advance appointment.
- **Fees:** 15 cents per page for copies made by researchers
50 cents per page (\$10.00 minimum) for copies made for researchers by Reagan Library staff *
- * ***If you plan to have the Library staff make copies, please inform the staff as soon as possible.***
- **Paying for copies:**
You must obtain a copy card from the research room attendant in order to use the self-service copier. This card will record the number of copies made.
Until payment is made, all copies will be retained at the research room front desk. Researchers may pay for their copies at any time, such as at the end of each day or at the end of their research visit. A receipt will be given for each payment made. If a researcher is unable to carry home a large volume of copies, the Library can mail the copies to an address supplied by the researcher.
Payment may be made by cash, check, money order, or credit card (Visa, MasterCard, American Express, or Discover/Novus). Checks and money orders must be made out to the National Archives Trust Fund.
- Researchers are responsible for properly citing documents, and for obtaining any necessary copyright or literary property rights.
- **Rules and procedures:**
All rules and procedures are intended to insure that documents are not damaged or misfiled, and to guarantee that everyone has a chance to use the copier. Archives staff may deny use of the copier to any researcher who fails to properly handle Library material.
- You may use our double tabs, available at the research room desk, to mark specific pages in a folder that you wish to copy. Simply place a tab over material to be copied.
- **Please preserve the order of documents within folders, and folders within boxes. Bring an entire box at a time, not individual folders or documents, to the photocopier. At the copier, remove from a box one folder, and only one folder, at a time. Use one of our marker cards to mark the exact place in the box from which you take each folder.**
- **All folders from which you make copies made must be presented to the research room attendant both before and after the copies are made, so that the attendant can check for preservation problems, and the proper order of documents within folders can be maintained.**
- Only one researcher may use the copier at a time. There is a 15-minute time limit when other researchers are waiting. If more than one researcher wishes to use the copier at a given time, the research room attendant may establish a waiting list.
- To allow us to distinguish photocopies from original materials, all self-service copies will be done on tinted paper, and will be marked "Reproduced at the Ronald Reagan Library" in one corner.
- Fragile documents, and documents larger than 8½ x 14 inches, may not be copied on the self-service copier.
- Only Reagan Library material may be copied.
- *Any additional questions you have about copying procedures or restrictions may be answered by the archives staff.*
